WHEREAS, on March 9, 2021, the Board of Supervisors adopted Resolution No. 21-25, providing for the implementation of the July 1, 2020 – December 31, 2021 Compensation Plan for Management & Confidential Employees; and

WHEREAS, the Board of Supervisors desires to amend Resolution No. 21-25, providing for the implementation of the July 1, 2020 – December 31, 2021 Compensation Plan for Management & Confidential Employees.


WHEREAS, California Employees Retirement System (CalPERS) does require all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors approves amendments to Resolution No. 21-25 to:

1. Adopt the new job classification (attachment 1 of the report this date) and salary range of Correctional Services Manager (Class 0943, Salary Range 448, Unit 08) into the salary range and classification plan effective immediately; and

The Board of Supervisors adopts a Comprehensive Compensation Schedule and Classification Summary (attachment 3 of the report this date) effective September 14, 2021.
