**RESOLUTION AUTHORIZING ESTABLISHMENT OF A REVOLVING PETTY CASH FUND FOR USE BY THE SHERIFF'S MCKINLEYVILLE SUBSTATION.**

**WHEREAS**, Sections 29320 et seq. of the Government Code authorizes the Board of Supervisors to establish revolving funds for use of any officer of the county; and

**WHEREAS**, the Sheriff has requested a revolving fund, in the amount of one-hundred dollars (\$100.00) for use by employees staffing the McKinleyville Substation to make change for citizens paying fees.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**


1. That the County of Humboldt establishes a revolving fund in the amount of one hundred dollars (\$100.00) to be used by staff of the McKinleyville Substation in accordance with the terms and conditions set forth above and subject to the provisions of Section 29320 et. seq. of the Government Code.
2. That the Clerk of the Board of Supervisors shall transmit certified copies of the Resolution to the Auditor and Treasurer for the County of Humboldt pursuant to Government Code 29322.
3. This resolution is effective immediately.
