PUBLIC NOTICE

On August 27, 2019, during its regularly scheduled Board meeting, the Humboldt County Board of Supervisors adopted Ordinance No. 2635, which amended Title III, Division 1, Chapter 4 of Humboldt County Code by adding Section 314-7.5 "TE - Timberland Exclusive" Principal Zone, adding Section 314-9.1 (MU1 - Mixed Use (Urban)) Principal Zone, adding Section 314-9.2 (MU2 - Mixed Use (Rural)) Principal Zone, adding Section 314-31.2 (PRD - Planned Rural Development Combining Zone); and by amending Section 314-7.1 (AE - Agriculture Exclusive Zone); and amending Section 314-7.4 (TPZ - Timberland Production Zone); and amending Section 314-17.1 (B-1 - Special Building Site) Combining Zone, to be consistent with the General Plan. The new zones and amendments to the existing zones will become effective thirty (30) days after the date of adoption. The names of the Supervisors voting for and against are as follows:
