
Subject: **2015 STREETS RESURFACING PROJECT, CONTRACT NO.: 325374**


RECOMMENDATION(S): That the Board of Supervisors:

1. Accepts the completed contract between Sierra Nevada Construction, Inc. and Humboldt County for the construction of the 2015 Streets Resurfacing project.
2. Approves the final payment, as submitted by the Public Works Department to the Auditor/Controller, in the amount of \$34,063.78 which is the five percent (5%) retention. This will bring the total amount paid to one hundred percent (100%) of the contract.



DISCUSSION:

The project consisted of micro-surfacing various roads in Humboldt County. This was a cooperative project allowing Public Works (County) and the Cities of Arcata, Eureka, Fortuna, and Trinidad (Cities) plus the County Library to take advantage of economy of scale, where lower bid prices are received associated with greater quantities of work. The Cities and the County Library reimbursed the County through individual funding agreements which were presented to your Board on August 18, 2015.

On June 23, 2015, the Board of Supervisors authorized the Clerk of the Board to advertise the above-referenced project for bids. On July 21, 2015, the County received five bids for the project. The contract was awarded to Sierra Nevada Construction, Inc., the lowest responsible bidder on August 18, 2015. The award amount was \$687,529.50. The final project total to \$681,275.55 or \$6,253.95 less than the contracted amount.

This is the fourth year of the Street Resurfacing Project. The first two years, the City of Arcata managed the project. This is the second year Humboldt County Department of Public Works managed the project. Next year the City of Eureka will be managing the project. This year the bid was \$0.19 higher per square yard than last year's which is contributed to the lateness in the season the project went out to bid. This next season it is anticipated to put the bid out in the winter of 2017 so the project would be first on their list for the 2017 construction season.

FINANCIAL IMPACT:

Total construction costs for this project were \$681,275.55. The County's portion of this project is being funded through the Measure Z Fund, Permanent Road Division 1 and 2 Fund, and the Road Fund. This project was included in the FY 2015-16 Road Maintenance budget.

The project conforms to the Board of Supervisors' Core Role of providing for and maintaining infrastructure and building inter-jurisdictional and regional cooperation as identified in the Board's Strategic Framework.


Subject: Project Acceptance for the City of Eureka Portion of Improvements for the County of Humboldt's 2015 Resurfacing Project
