

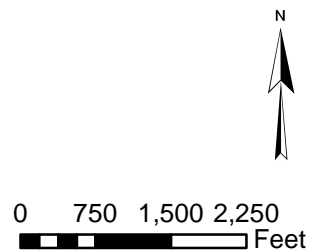
LOCATION MAP

Coastal Zone Boundary 

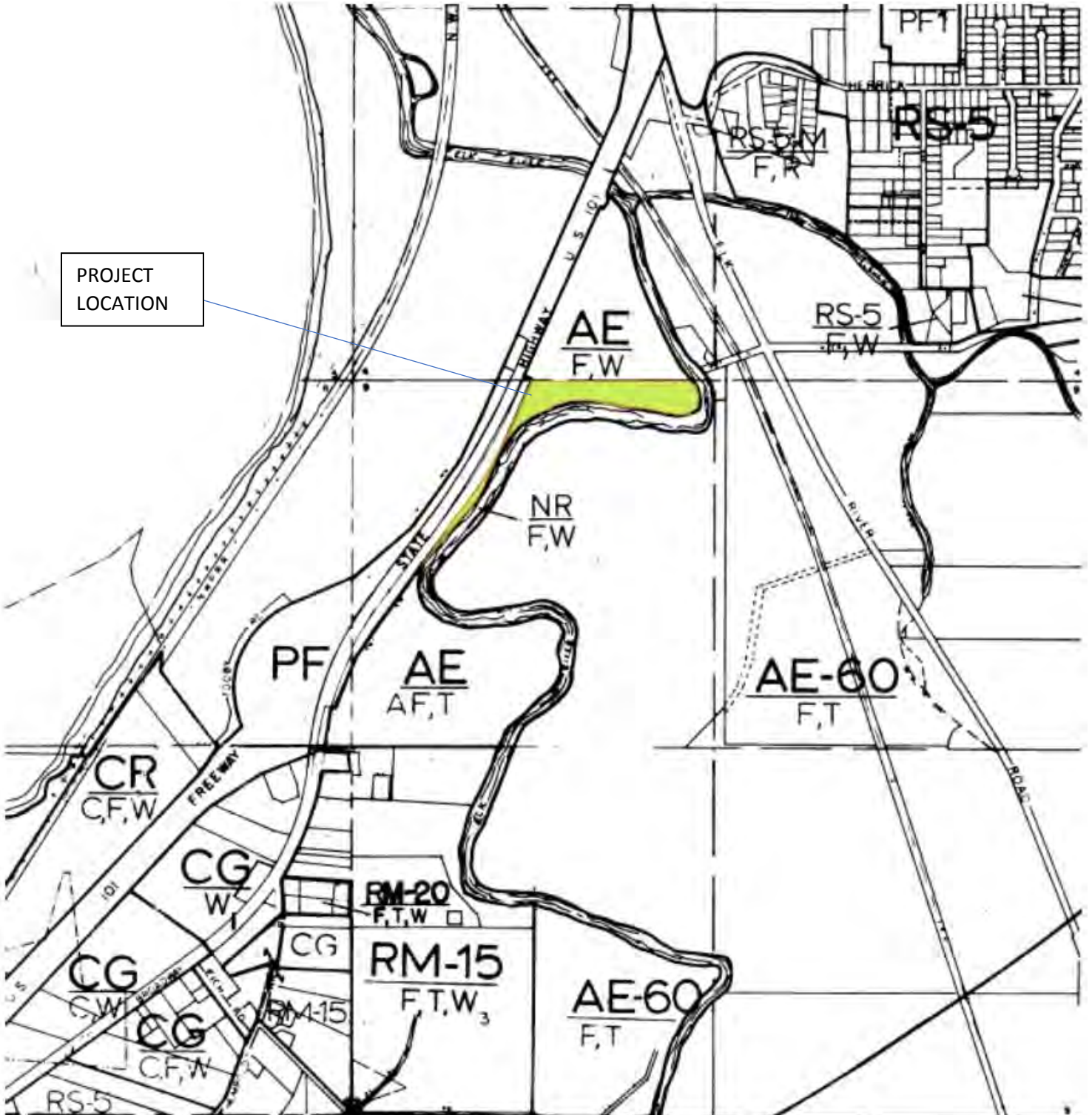

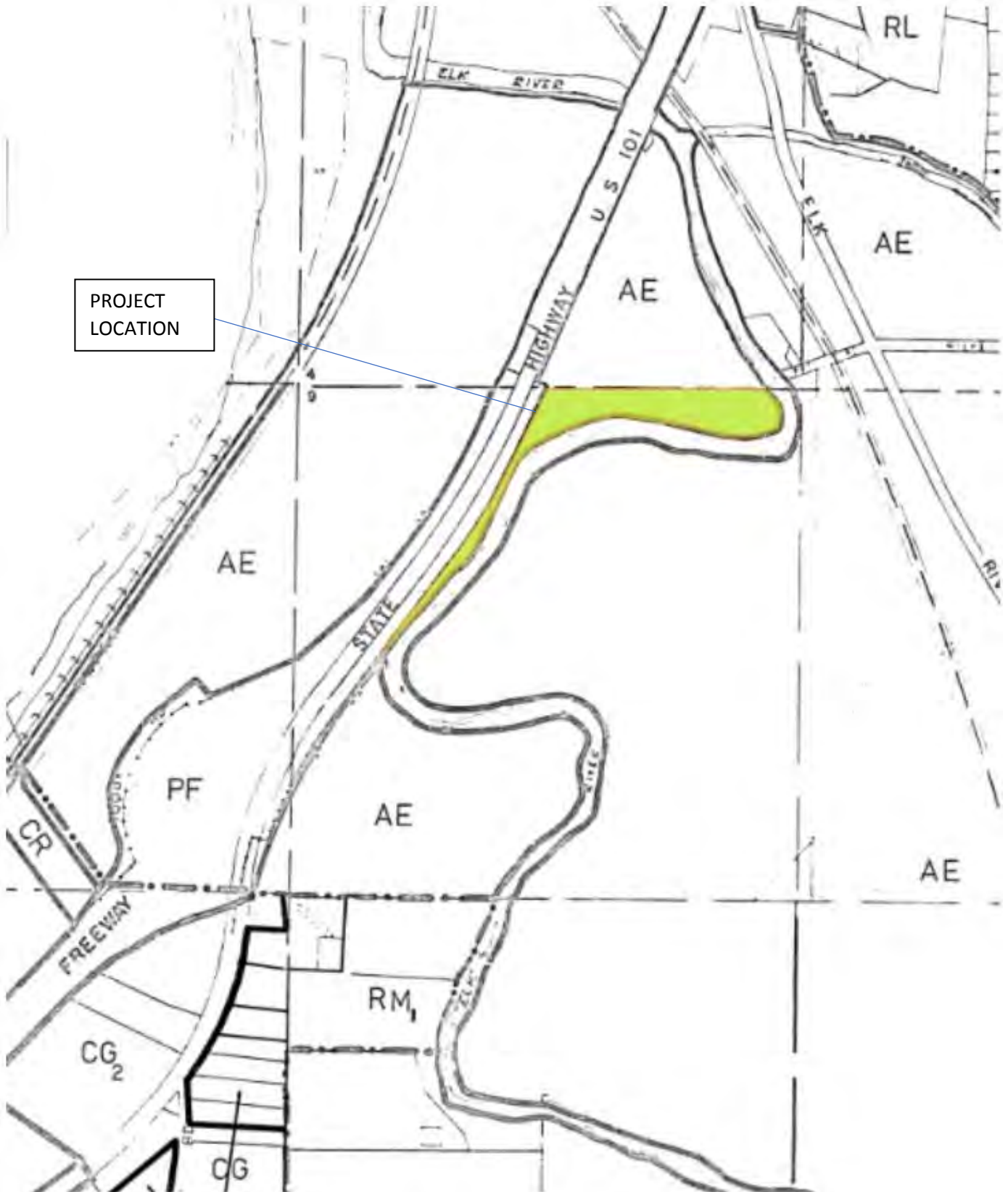

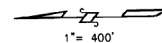
LAND USE MAP

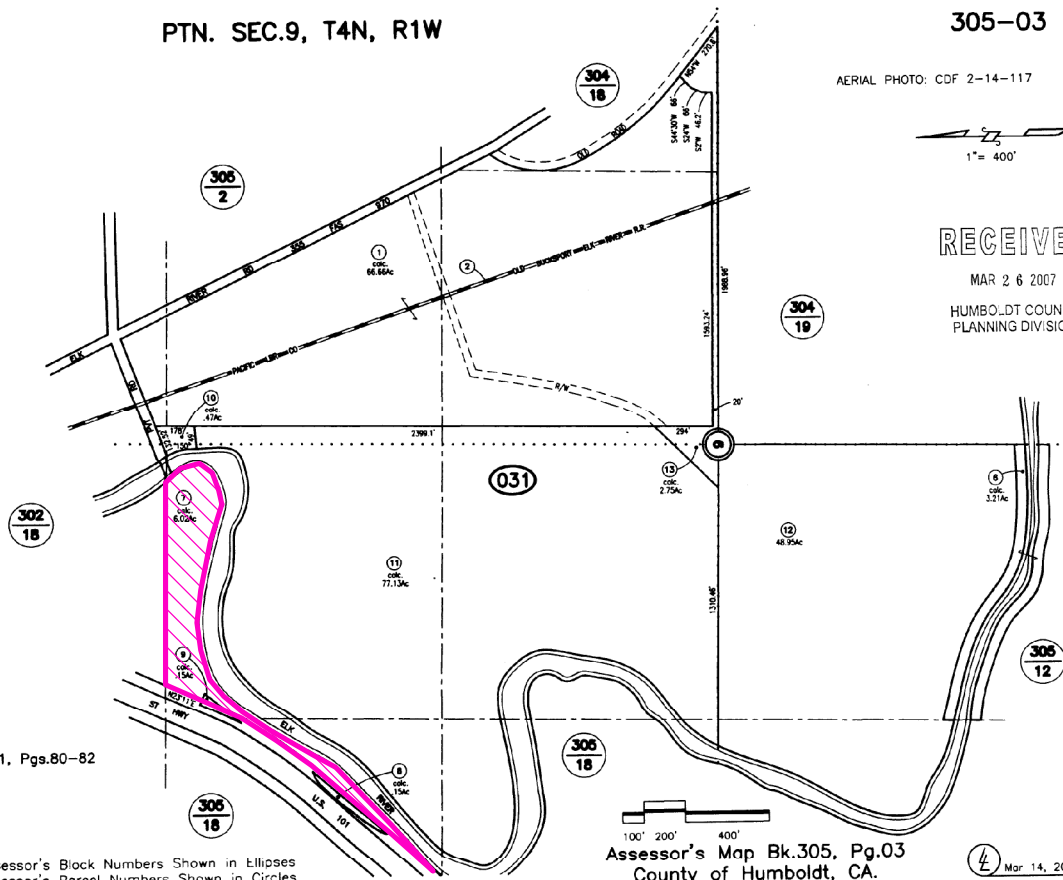

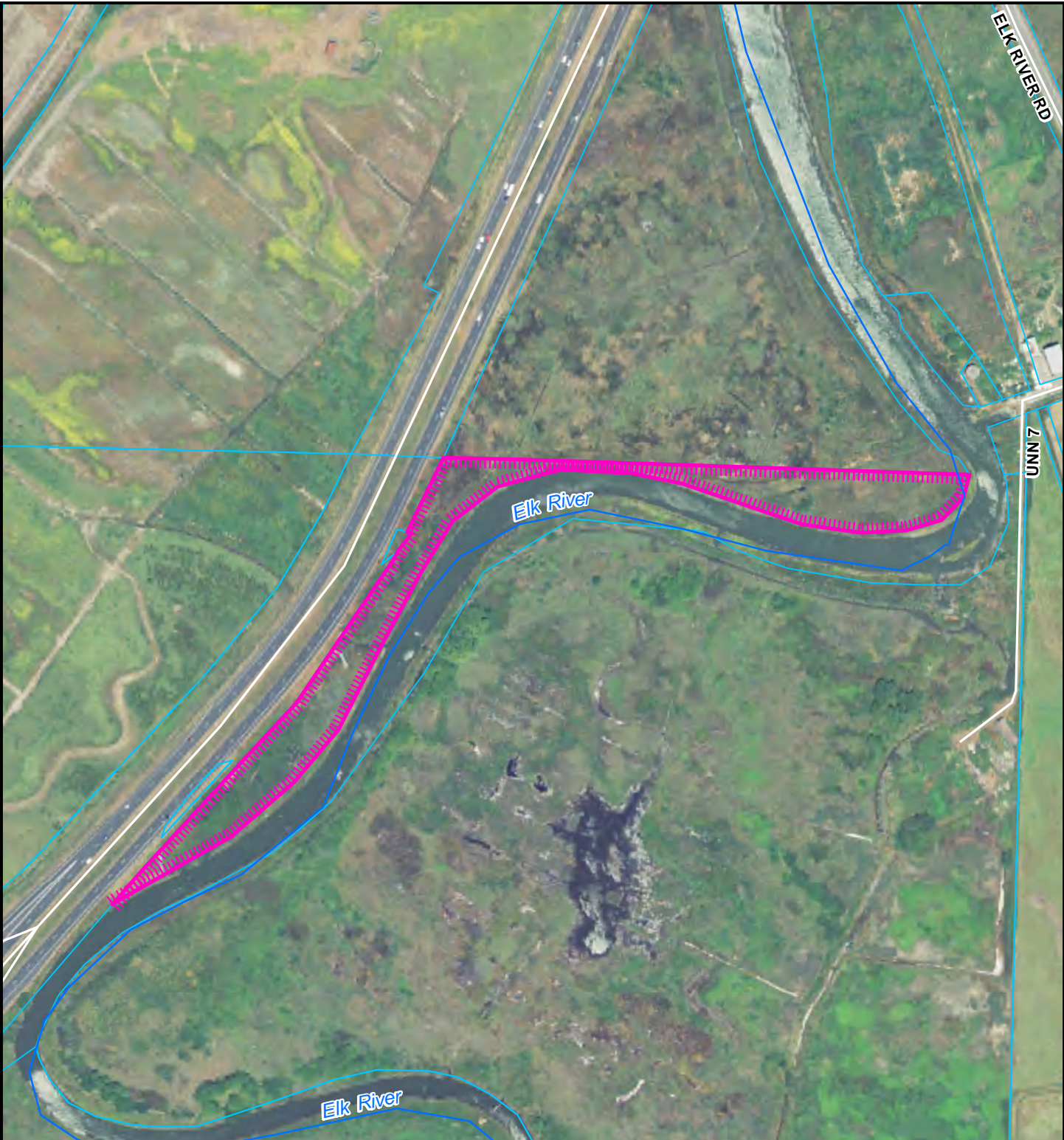

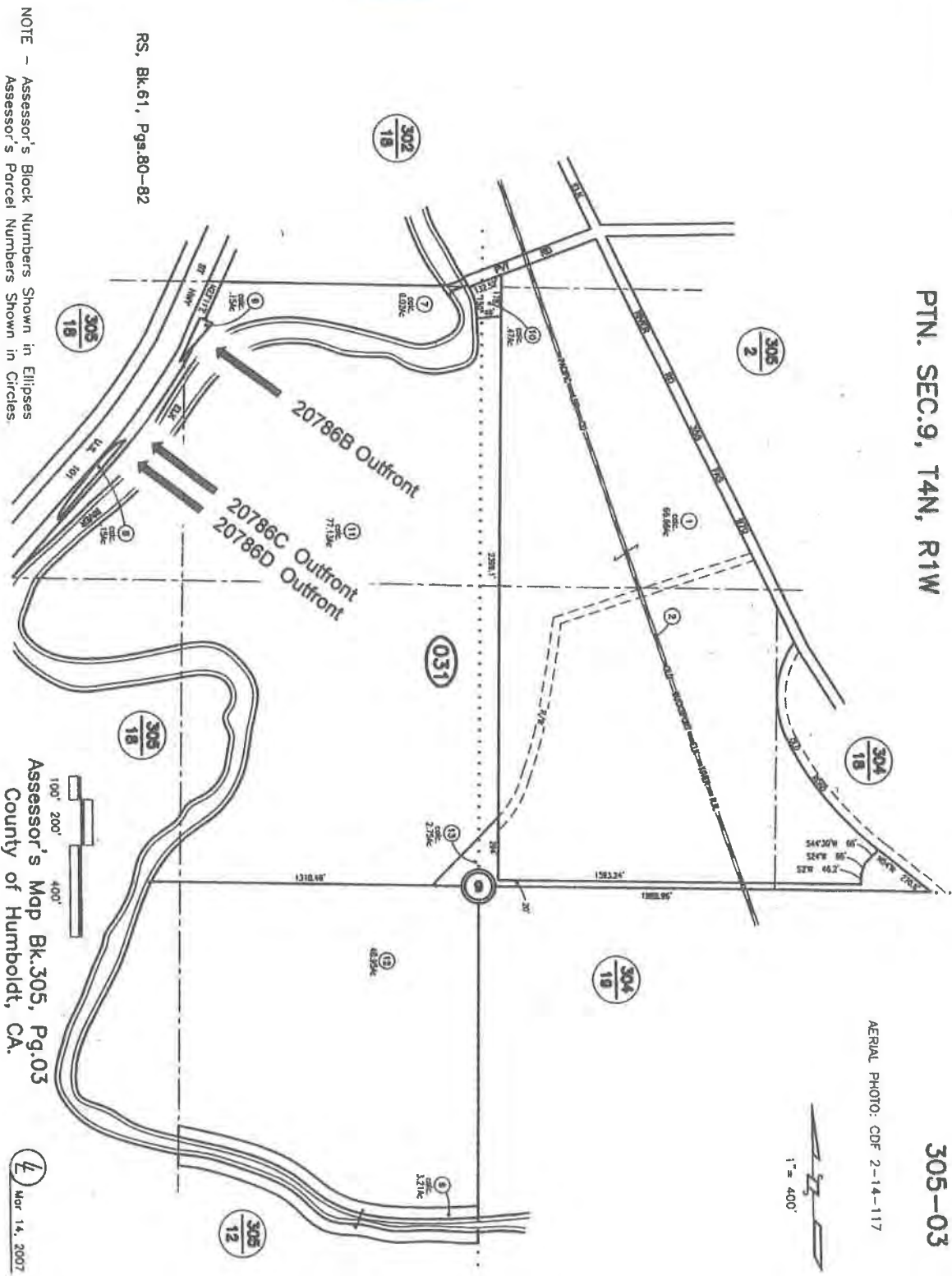

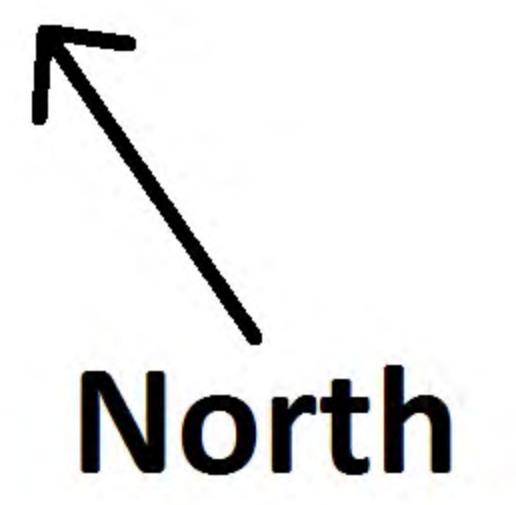
