I do not support the letter that Mike Wilson wrote. Much of it is factual, but Coast Seafoods' current dilemma is entirely of their own making. If they, with their attorneys, have not yet figured out that they really do have to follow the rules, then why would the BOS want to send a letter in their support?

I support oyster farming in our bay. I support reasonable, considered expansion of cultivation. I do not support a company which makes, and seeks to continue making, many millions of dollars annually from the use of our bay (most of which benefits an out-of-state corporation,) which chooses not to follow California policy (and yes, that is a challenge!!) and then comes to you begging for support.

There is also some nebulous wording in Mike's letter. Approval of the letter needs to be tabled until the entire Board is there to discuss it.
