**WHEREAS**, the Board of Supervisors intends to amend the 2022-2024 Compensation Plan for Designated Management and Confidential Employees; and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

- 1. Adopt the new job classification specification of Assistant Director of Public Health Nursing (class 0498, salary range 570 bargaining unit 008) into the classification plan effective the pay period following board approval;
- 2. Increase the salary range for the Director of Public Health Nursing (salary range 573, class 0508) to range 580 effective the first full pay period following Board approval;
- Increase the salary range for the Health & Human Services Mental Health Branch
  Director (salary range 586, class 0545) to range 590 effective the first full pay period
  following Board approval;
- 4. Adopt the Resolution approving the amendment of the January 1, 2022 December 31, 2024, Compensation Plan for Designated Management and Confidential Employees; and
- 5. Adopt the Comprehensive Compensation Schedule and Classification Summary effective March 3, 2024.
