# MEMORANDUM OF UNDERSTANDING BY AND BETWEEN COUNTY OF HUMBOLDT AND BLUE LAKE RANCHERIA FOR FISCAL YEAR 2020-2021

This Memorandum of Understanding ("MOU"), entered into this 29<sup>th</sup> day of July 2020, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Blue Lake Rancheria, a Federally recognized Tribe, hereinafter referred to as "BLUE LAKE," is made upon the following considerations:

WHEREAS, a novel coronavirus, COVID-19, causes infectious disease and was first detected in Wuhan City, Hubei Province, China in December 2019, and symptoms of COVID-19 include fever, cough and shortness of breath and outcomes have ranged from mild to severe illness, and in some cases death; and

WHEREAS, on January 31, 2020, U.S. Department of Health and Human Services Secretary Alex M. Azar II declared a public health emergency for the United States to aid the nation's health care community in responding to COVID-19; and

WHEREAS, the Centers for Disease Control and Prevention has determined that the virus presents a serious public health threat; and

WHEREAS, Humboldt County had its first confirmed case of COVID-19 on February 20, 2020, and the potential of more COVID-19 cases in Humboldt County is an imminent threat; and

WHEREAS, on March 4, 2020, Governor Gavin Newsom proclaimed a state of emergency to exist in California; and

WHEREAS, on March 11, 2020, Humboldt County Health Officer declared a Local Health Emergency pursuant to Humboldt County Code section 2210-8 for a up to seven (7) days in the county or any area thereof, including but not limited to an imminent and proximate public health threat of the introduction of any contagious, infectious, or communicable disease, chemical agent, noncommunicable biologic agent, toxin, or radioactive agent; and

WHEREAS, on March 13, 2020, President Donald J. Trump declared a federal state of emergency regarding the global pandemic caused by COVID-19; and

WHEREAS, on March 17, 2020, Humboldt County Board of Supervisors ratified the Humboldt County Health Officer's March 11, 2020 Local Health Emergency Declaration; and

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Public Health ("DHHS – Public Health"), desires to work collaboratively with BLUE LAKE to deploy and operate emergency operations during the COVID-19 pandemic; and

WHEREAS, the parties wish to memorialize the current agreement between the parties for the services provided by BLUE LAKE; and

WHEREAS, COUNTY and BLUE LAKE desire to enter into an agreement which sets forth each party's rights and responsibilities regarding the operation thereof.

NOW THEREFORE, in consideration of the foregoing and the mutual promises contained herein, the parties hereto mutually agree as follows:

#### 1. RIGHTS AND RESPONSIBILITIES OF THE PARTIES:

Each party hereto agrees to cooperate, coordinate and work collaboratively with the other party to deploy and operate emergency operations during the COVID-19 pandemic, utilizing BLUE LAKE's facilities located at 428 Chartin Road, Blue Lake, California, hereinafter referred to as "Facility," in accordance with the requirements set forth herein and Exhibit A – Shared Responsibilities, which is attached hereto and incorporated herein by reference.

#### 2. TERM:

This MOU shall begin July 1, 2020 and shall remain in full force and effect until August 31, 2020, unless sooner terminated as provided herein. This MOU may be renewed by mutual written agreement by the parties for successive sixty (60) day periods as required.

#### 3. TERMINATION:

- A. <u>Breach of Contract</u>. Either party may immediately terminate this MOU, upon written notice, in the event that the other party materially defaults in performing any obligation under this MOU, or violates any laws, regulations or standards applicable to its performance hereunder.
- B. <u>Without Cause</u>. Either party may terminate this MOU without cause upon twenty-one (21) days advance written notice which states the effective date of the termination.
- C. <u>Insufficient Funding</u>. The obligations of both parties under this MOU are contingent upon the availability of local (both County and Tribal), state and/or federal funds. In the event such funding is reduced, eliminated, or no longer available or adequate for any reason, either party shall, at its sole discretion, determine whether this MOU shall be terminated. Upon making that determination, the party shall provide the other party seven (7) days advance written notice of its intent to terminate this MOU due to insufficient or inadequate funding.

#### 4. NOTICES:

Any and all notices required to be given pursuant to the terms and conditions of this MOU shall be in writing and served personally, by email with tracking enabled (when receipt has acknowledged) or sent by certified mail, return receipt requested, to the respective addresses set forth below. Notice shall be effective upon actual receipt or refusal as shown on the receipt obtained pursuant to the foregoing.

Either party can change the above addresses by written notice to the other party.

#### 5. REPORTING REQUIREMENTS:

Each party hereto agrees to prepare and submit any and all reports that may be required by local, state and/or federal agencies for compliance with this MOU. Any and all reports required hereunder shall be prepared in a format that complies with the Americans with Disabilities Act, and any other applicable local, state and federal accessibility laws, regulations and standards, and submitted in accordance with any and all applicable timeframes.

#### 6. NON-DISCRIMINATION COMPLIANCE:

- A. Professional Services and Employment. In connection with the execution of this MOU, COUNTY shall not unlawfully discriminate in the provision of professional services or against any employee or applicant for employment because of: race; religion or religious creed; color; age (over forty (40) years of age); sex, including, without limitation, gender identity and expression, pregnancy, childbirth and related medical conditions; sexual orientation, including, without limitation, heterosexuality, homosexuality and bisexuality; national origin; ancestry; marital status; medical condition, including, without limitation, cancer and genetic characteristics; mental or physical disability, including, without limitation, HIV status and AIDS; political affiliation; military service; denial of family care leave; or any other classifications protected by any applicable local, state or federal laws, regulations or standards. Nothing herein shall be construed to require employment of unqualified persons.
- B. Compliance with Anti-Discrimination Laws. COUNTY further assures that it will abide by the applicable provisions of: Title VI and Title VII of the Civil Rights Act of 1964; Section 504 of the Rehabilitation Act of 1973; the Age Discrimination Act of 1975; the Food Stamp Act of 1977; Title II of the Americans with Disabilities Act of 1990; the California Fair Employment and Housing Act; California Civil Code Sections 51, et seq.; California Government Code Sections 4450, et seq.; California Welfare and Institutions Code Section 10000; Division 21 of the California Department of Social Services Manual of Policies and Procedures; United States Executive Order 11246, as amended and supplemented by United States Executive Order 11375 and 41 C.F.R. Part 60; and any other applicable local, state and/or federal laws and regulations, all as may be amended from time to time. The applicable regulations of the California Fair Employment and Housing commission implementing California Government Code Section 12990, set forth in Sections 8101, et seq. of Title 2 of the California Code of Regulations are incorporated into this MOU by reference as if set forth in full.

#### 7. NUCLEAR-FREE HUMBOLDT COUNTY ORDINANCE COMPLIANCE:

By executing this MOU, BLUE LAKE certifies that it is not a Nuclear Weapons Contractor, in that BLUE LAKE is not knowingly or intentionally engaged in the research, development, production or testing of nuclear warheads, nuclear weapons systems or nuclear weapons components as defined by the Nuclear Free Humboldt County Ordinance. BLUE LAKE agrees to notify COUNTY immediately if it becomes a Nuclear Weapons Contractor as defined above. COUNTY may immediately terminate this MOU if it determines that the foregoing certification is false or if BLUE LAKE subsequently becomes a Nuclear Weapons Contractor.

#### 8. INDEMNIFICATION:

- A. Mutual Indemnity. To the extent covered by the insurance policies required by Section 11 of this MOU, each party hereto shall hold harmless, defend and indemnify the other party and its agents, officers, officials, employees and volunteers from and against any and all claims, demands, losses, damages, liabilities, expenses and costs of any kind or nature, including, without limitation, attorney's fees and other costs of litigation, arising out of, or in connection with, the negligent performance of, or failure to comply with, any of the duties and/or obligations contained herein, except such loss or damage which was caused by the sole negligence or willful misconduct of the other party or its agents, officers, officials, employees or volunteers.
- B. <u>Comparative Liability</u>. Notwithstanding anything to the contrary, in the event that both parties are held to be negligently or willfully responsible, each party will bear their proportionate share of liability as determined in any such proceeding. In such cases, each party will bear their own costs and attorney's fees.
- C. <u>Claim Requirements</u>. Nothing in this agreement waives any claim filing requirements applicable to claims for the payment of money by either party under California or Tribal law.

#### 9. INSURANCE REQUIREMENTS:

- A. General Insurance Requirements. Each party shall maintain in full force and effect, at its own expense, any and all appropriate comprehensive general liability, comprehensive automobile, and workers' compensation policies.
- B. <u>Insurance Notices</u>. Any and all insurance notices required to be given pursuant to the terms and conditions of this MOU shall be sent to the addresses set forth below in accordance with the notice requirements contained herein.

#### 10. RELATIONSHIP OF PARTIES:

It is understood that this MOU is by and between two (2) independent entities and is not intended to, and shall not be construed to, create the relationship of agent, servant, employee, partnership, joint venture or any other similar association. Each party shall be solely responsible for the acts or omissions of its agents, officers, employees, assignees and subcontractors.

#### 11. COMPLIANCE WITH APPLICABLE LAWS, REGULATIONS AND STANDARDS:

- A. General Legal Requirements. Each party hereto agrees to comply with any and all local, state and federal laws, regulations, policies, procedures and standards, including, without limitation, any and all local, state and federal licensure, certification and accreditation requirements, applicable to its performance hereunder.
- B. Accessibility Requirements. To the extent that the following is applicable to BLUE LAKE, in performing under this MOU, each party hereto agrees to comply with any and all applicable accessibility requirements set forth in the Americans with Disabilities Act, Section 508 of the Rehabilitation Act of 1973, as amended, California Government Code Section 1135 and any current and future implementing regulations, policies, procedures and standards promulgated thereunder, including, without limitation, the federal accessibility standards set forth in 36 C.F.R. Section 1194.1, all as may be amended from time to time.

# 12. PROVISIONS REQUIRED BY LAW:

This MOU is subject to any additional local, state and federal restrictions, limitations or conditions that may affect the terms, conditions or funding of this MOU.

#### 13. REFERENCE TO LAWS, REGULATIONS AND STANDARDS:

In the event any law, regulation or standard referred to herein is amended during the term of this MOU, the parties agree to comply with the amended provision as of the effective date thereof.

#### 14. PROTOCOLS:

Both parties agree that the inclusion of additional protocols may be required to make this MOU specific. All such protocols shall be negotiated, determined and agreed upon by both parties hereto.

# 15. SEVERABILITY:

If any provision of this MOU, or any portion thereof, is found by any court of competent jurisdiction to be unenforceable or invalid for any reason, such provision shall be severable and shall not in any way impair the enforceability of any other provision of this MOU.

#### 16. ASSIGNMENT:

Neither party shall delegate its duties nor assign its rights hereunder, either in whole or in part, without the other party's prior written consent. Any assignment in violation of this provision shall be void, and shall be cause for immediate termination of this MOU. This provision shall not be applicable to service agreements or other arrangements usually or customarily entered into by either party to obtain supplies, technical support or professional services.

#### 17. AGREEMENT SHALL BIND SUCCESSORS:

All provisions of this MOU shall be fully binding upon, and shall inure to the benefit of, the parties and to each of their heirs, executors, administrators, successors and permitted assigns.

#### 18. NO WAIVER OF DEFAULT:

The waiver by either party of any breach of this MOU shall not be deemed to be a waiver of any such breach in the future, or of the breach of any other requirement of this MOU.

# 19. NON-LIABILITY OF OFFICIALS AND EMPLOYEES:

No official or employee of either party shall be personally liable for any default or liability under this MOU.

#### 20. AMENDMENT:

This MOU may be amended at any time during the term hereof upon the mutual consent of both parties. No addition to, or alteration of, the terms of this MOU shall be valid unless made in writing and signed by an authorized representative of each party hereto.

#### 21. JURISDICTION AND VENUE:

This MOU shall be construed in accordance with the laws of the State of California. Any dispute arising hereunder, or relating hereto, shall be litigated in the State of California and venue shall lie in the County of Humboldt unless transferred by court order pursuant to California Code of Civil Procedure Sections 394 or 395.

#### 22. ADVERTISING AND MEDIA RELEASE:

Each party shall obtain the written approval of the other party before any informational material related to this MOU may be used as advertising or released to the media, including, without limitation, television, radio, newspapers and internet. Each party shall inform the other party of any and all requests for interviews by media related to this MOU before such interviews take place; and the other party shall be entitled to have a representative present at such interviews. All notices required by this provision shall be given to the Director in accordance with the notice requirements set forth herein.

#### 23. SUBCONTRACTS:

Each party shall obtain prior written approval from the other party, which shall not be unreasonably withheld, before subcontracting any of its duties or obligations hereunder. Any and all subcontracts shall be subject to all applicable terms and conditions of this MOU, including, without limitation, the confidentiality, licensing and certification requirements set forth herein. Each party shall remain legally responsible for the performance of all terms and conditions of this MOU, including, without limitation, any and all duties performed by third parties under subcontracts, whether approved by the other party or not.

#### 24. SURVIVAL OF PROVISIONS:

The duties and obligations of the parties set forth in Section 6 – Record Retention and Inspection, Section 7 – Confidential Information and Section 10 – Indemnification shall survive the expiration or termination of this MOU.

#### 25. CONFLICTING TERMS OR CONDITIONS:

In the event of any conflict in the terms or conditions set forth in any other agreements in place between the parties hereto and the terms and conditions set forth in this MOU, the terms and conditions set forth herein shall have priority.

#### 26. INTERPRETATION:

This MOU, as well as its individual provisions, shall be deemed to have been prepared equally by both of the parties hereto, and shall not be construed or interpreted more favorably for one (1) party on the basis that the other party prepared it.

#### 27. INDEPENDENT CONSTRUCTION:

The titles of the sections and subsections set forth herein are inserted for convenience of reference only and shall be disregarded in construing or interpreting any of the provisions of this MOU.

#### 28. FORCE MAJEURE:

Neither party hereto shall be liable or responsible for delays or failures in performance resulting from events beyond the reasonable control, and without the fault or negligence, of such party. Such events shall include, without limitation, acts of God, strikes, lockouts, riots, acts of war, epidemics, acts of government, fire, power failures, nuclear accidents, earthquakes, unusually severe weather, acts of terrorism or other disasters, whether or not similar to the foregoing.

#### 29. ENTIRE AGREEMENT:

This MOU contains all of the terms and conditions agreed upon by the parties hereto and no other agreements, oral or otherwise, regarding the subject matter of this MOU shall be deemed to exist or to bind either of the parties hereto. In addition, this MOU shall supersede in their entirety any and all prior agreements, promises, representations, understandings and negotiations of the parties, whether oral or written, concerning the same subject matter. Any and all acts which may have already been consummated pursuant to the terms and conditions of this MOU are hereby ratified.

#### 30. COUNTERPART EXECUTION:

This MOU, and any amendments hereto, may be executed in one (1) or more counterparts, each of which shall be deemed to be an original and all of which, when taken together, shall be deemed to be one (1) and the same agreement. This MOU, and any amendments hereto, may be signed by manual or electronic signatures in accordance with any and all applicable local, state and federal laws, regulations and standards, and such signatures shall constitute original signatures for all purposes. A signed copy of this MOU, and any amendments hereto, transmitted by email or by other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this MOU and any amendments hereto.

#### 31. LIMITED WAIVER OF TRIBAL SOVEREIGN IMMUNITY

BLUE LAKE does not waive its sovereign immunity or consent to suit in any court except as expressly stated in this section and subject to the limitations and considerations stated in this section.

- A. <u>Limited Waiver and Consent to Suit</u>: BLUE LAKE waives its sovereign immunity and consents to suit as to "Covered Claims" as defined in Section (A)(2) below. BLUE LAKE's governing body has executed a formal Resolution of Limited Waiver of Sovereign Immunity which is attached hereto as Exhibit C.
  - Conditions and Limitations: This waiver and consent is subject to the following conditions and limitations:

- 2. Covered Claims: This waiver and consent only applies to claims by COUNTY that BLUE LAKE has violated any provision of this MOU or that seeks to resolve a dispute concerning the interpretation, implementation or enforcement of this MOU. It does not include tort claims, claims for exemplary or punitive damages, or any other claims not sounding in contract. It does not waive the Tribe's sovereign immunity as to any claim for prejudgment interest.
- Covered Claimants: This waiver and consent only applies to COUNTY, and not to any
  other person, entity, including any commercial or governmental entity, or group.
- Covered Courts: This consent to suit only applies to the California State Courts in Humboldt County, and appropriate state appellate courts. BLUE LAKE does not consent to suit in any other court.
- 5. <u>Remedies</u>: This waiver and consent is specifically limited to an award of monetary damages constituting a reimbursement of funds for obligations not performed by BLUE LAKE under the terms of this MOU, and/or specific performance to compel enforcement of this MOU. This waiver of immunity specifically does not allow for recovery of attorneys' fees or other costs associated with litigation of Covered Claims.
- 6. <u>Duration</u>: Notwithstanding any applicable statute of limitations or other law, this limited waiver shall be enforceable only for such period as this MOU remains in effect, and only as to claims arising during the effective period of this MOU, except that this limited waiver of sovereign immunity shall remain effective for any proceeding pending prior to the termination of this Agreement and all appeals therefrom until the underlying legal claim or claims have been finally determined.

#### 32. AUTHORITY TO EXECUTE:

Each person executing this MOU represents and warrants that he or she is duly authorized and has legal authority to execute and deliver this MOU. Each party represents and warrants to the other that the execution and delivery of this MOU and the performance of such party's obligations hereunder have been duly authorized.

#### 33. FEDERAL PROVISIONS:

- A. BLUE LAKE acknowledges that Federal Emergency Management Agency (FEMA) financial assistance will be used to fund this Agreement. BLUE LAKE will comply with all applicable federal law, regulations, executive orders, FEMA policies, procedures, and directives.
- BLUE LAKE shall at all times comply with all applicable regulations, policies, procedures, and FEMA Directives as they may be amended or promulgated from time to time during the term of this Agreement, including but not limited to those requirements of 2 CFR 200.317 through 200.326 and more fully set forth in Appendix II to Part 200—Contract Provisions for non-Federal Entity Contracts Under Federal Awards, which is included herein by reference. BLUE LAKE's failure to so comply shall constitute a material breach of this contract.
- C. BLUE LAKE agrees to include the above clause in each third-party subcontract financed in whole or in part with Federal assistance provided by FEMA. It is further agreed that the clause shall not be modified, except to identify the subcontractor who will be subject to its provisions.
- D. Whether or not expressly set forth herein, all contractual provisions required by FEMA are

hereby incorporated by reference. In the event of any conflict between any provision of this Agreement or any FEMA term, condition, or requirement, the stricter standard shall apply. BLUE LAKE shall not perform any act, fail to perform any act, or refuse to comply with any requests that would cause COUNTY to be in violation of any FEMA term, condition, or requirement.

E. Subject to the limits on its waiver of sovereign immunity as set forth in Section 31, BLUE LAKE agrees that the Federal provisions described in Exhibit B – Federal Provisions, which is attached hereto and incorporated herein by reference as if set forth in full applies to BLUE LAKE's acts or omissions in its performance under this MOU.

# EXHIBIT A SHARED RESPONSIBILITIES

BLUE LAKE RANCHERIA For Fiscal Year 2020-2021

#### 1. RESPONSIBILITIES OF BLUE LAKE:

a. Provide frozen meals for pick up by COUNTY staff at its Facility.

b. Submit monthly invoices to COUNTY itemizing all meals ordered pursuant to the terms and conditions of this MOU. Invoices shall be submitted to COUNTY within ten (10) days after the end of each calendar month and shall be sent to the following address:

#### 2. RESPONSIBILITIES OF COUNTY:

a. Designate staff to pick up prepared meals from BLUE LAKE's Facility.

 Designated COUNTY staff will wear the following Personal Protective Equipment when picking up meals:

1. Disposable latex or rubber gloves, as available; and

A surgical face mask or its equivalent designed, at a minimum, to protect persons against droplet transmission.

 Designated COUNTY staff will not enter into any buildings owned or operated by BLUE LAKE.

b. Inform BLUE LAKE of how many meals to prepare for pick up by COUNTY staff.

c. Provide a minimum of twenty-four (24) hours of meal preparation time to BLUE LAKE prior to pick up.

d. Reimburse BLUE LAKE for meals at a rate of Four Dollars (\$4.00) per meal. Payment shall be made to BLUE LAKE within thirty (30) days after the receipt of approved invoices.

# EXHIBIT B FEDERAL PROVISIONS

Blue Lake Rancheria For Fiscal Year 2020-2021

#### ACCESS TO RECORDS:

The following access to records requirements applies to this MOU:

- A. BLUE LAKE agrees to provide the COUNTY, the FEMA Administrator, the Comptroller General of the United States, or any of their authorized representatives access to any books, documents, papers, and records of BLUE LAKE which are directly pertinent to this MOU for the purposes of making audits, examinations, excerpts, and transcriptions.
- B. BLUE LAKE agrees to permit any of the foregoing parties to reproduce by any means whatsoever or to copy excerpts and transcriptions as reasonably needed.
- C. BLUE LAKE agrees to provide the FEMA Administrator or their authorized representatives access to construction or other work sites pertaining to the work being completed under the MOU.
- D. In compliance with the Disaster Recovery Act of 2018, the COUNTY and BLUE LAKE acknowledge and agree that no language in this MOU is intended to prohibit audits or internal reviews by the FEMA Administrator or the Comptroller General of the United States.

#### 2. REMEDIES:

In the event of a breach by BLUE LAKE of any term or provision of this MOU, the COUNTY shall have the right to pursue all available remedies at law or equity, including recovery of damages and specific performance of this MOU. The parties hereto agree that monetary damages would not provide adequate compensation for any losses incurred by reason of a breach by it of any of the provisions of this MOU and hereby further agrees that, in the event of any action for specific performance in respect of such breach, it shall waive the defense that a remedy at law would be adequate. Except as expressly provided elsewhere in this MOU, each party's rights and remedies under this MOU are cumulative and in addition to, not exclusive of or in substitution for, any rights or remedies otherwise available to that party.

#### 3. CLEAN AIR ACT:

BLUE LAKE agrees to comply with all applicable standards, orders, or regulations issued pursuant to the Clean Air Act, as amended, 42 U.S.C. Section 7401 et seq.

BLUE LAKE agrees to report each violation to the COUNTY and understands and agrees that the COUNTY will, in turn, report each violation as required to assure notification to the California Governor's Office of Emergency Services, Federal Emergency Management Agency (FEMA), and the appropriate Environmental Protection Agency Regional Office.

BLUE LAKE agrees to include these requirements in each subcontract exceeding \$150,000 financed in whole or in part with Federal assistance provided by FEMA.

#### 4. FEDERAL WATER POLLUTION CONTROL ACT:

BLUE LAKE agrees to comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. Sections 1251 et seq.

BLUE LAKE agrees to report each violation to the COUNTY and understands and agrees that the COUNTY will, in turn, report each violation as required to assure notification to the Federal Emergency Management Agency (FEMA), and the appropriate Environmental Protection Agency Regional Office.

BLUE LAKE agrees to include these requirements in each subcontract exceeding \$150,000 financed in whole or in part with Federal assistance provided by FEMA.

## 5. DEBARMENT AND SUSPENSION CLAUSE:

This MOU is a covered transaction for purposes of 2 C.F.R. pt. 180 and 2 C.F.R. pt. 3000. As such, BLUE LAKE is required to verify that none of BLUE LAKE, its principals (defined at 2 C.F.R. § 180.995), or its affiliates (defined at 2 C.F.R. § 180.905) are excluded (defined at 2 C.F.R. § 180.940) or disqualified (defined at 2 C.F.R. § 180.935).

BLUE LAKE must comply with 2 C.F.R. pt. 180, subpart C and 2 C.F.R. pt. 3000, subpart C and must include a requirement to comply with these regulations in any lower tier covered transaction it enters into.

This certification is a material representation of fact relied upon by the COUNTY. If it is later determined that BLUE LAKE did not comply with 2 C.F.R. pt. 180, subpart C and 2 C.F.R. pt. 3000, subpart C, in addition to remedies available to the COUNTY, the Federal Government may pursue available remedies, including but not limited to suspension and/or debarment.

The bidder or proposer agrees to comply with the requirements of 2 C.F.R. pt. 180, subpart C and 2 C.F.R. pt. 3000, subpart C while this offer is valid and throughout the period of any contract that may arise from this offer. The bidder or proposer further agrees to include a provision requiring such compliance in its lower tier covered transactions.

#### 6. BYRD ANTI-LOBBYING AMENDMENT, 31 U.S.C. §1352 (AS AMENDED)

If BLUE LAKE applies or bids for an award of \$100,000 or more, BLUE LAKE shall file the required certification. Each tier certifies to the tier above that it will not and has not used Federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any Federal contract, grant, or any other award covered by 31 U.S.C. § 1352. Each tier shall also disclose any lobbying with non-Federal funds that takes place in connection with obtaining any Federal award. Such disclosures are forwarded from tier to tier up to the recipient who in turn will forward the certification(s) to COUNTY.

Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

BLUE LAKE certifies or affirms the truthfulness and accuracy of each statement of its certification and disclosure, if any. In addition, BLUE LAKE understands and agrees that the provisions of 31 U.S.C. § 3801 et seq., apply to this certification and disclosure, if any.

BLUE LAKE acknowledges that 31 U.S.C. Chapter 38 (Administrative Remedies for False Claims and Statements) applies to the BLUE LAKE's actions pertaining to this MOU.

#### **RESOLUTION NO. 20-14**

SUBJECT: RESOLUTION OF THE BUSINESS COUNCIL OF THE BLUE LAKE RANCHERIA

PROVIDING A LIMITED WAIVER OF SOVEREIGN IMMUNITY

#### WHEREAS:

 The Blue Lake Rancheria ("Tribe") is a federally recognized Indian tribe organized under a tribal constitution approved by the Secretary of Interior pursuant to Section 16 of the Indian Reorganization Act (("IRA"; 25 U.S.C. §5123); and

- 2. Under the Constitution of the Blue Lake Rancheria ("Tribal Constitution") adopted by the Tribe on February 11, 1994, and approved by the Secretary of the United States Department of Interior on March 7, 1994, with amendments approved by the Secretary on March 4, 2001, certain powers are reserved to the General Council which consists of all voting members of the Tribe and other powers are delegated to the tribal Business Council, consisting of a Chairperson, Vice- Chairperson, Secretary and Treasurer and two additional members, all elected by the general council; and
- While the Business Council is designated in the Tribal Constitution as the Tribe's governing body, the power to waive the Tribe 's immunity from suit is reserved in Article V, §3.h to the General Council; and
- 4. As provided in Article V of the Tribal Constitution, by a two-thirds vote of its eligible voters, the General Council can delegate the authority to waive the Tribe's sovereign immunity to the General Council; and
- 5. On October 12, 2019, in General Council Resolution No. 19-38, the General Council by two thirds vote of its eligible voters authorized the Business Council for the period October 12, 2019 to October 10, 2020, to waive by a resolution adopted by majority vote of the Business Council members the sovereign immunity of the Tribe when required by parties to a contract with the Tribe; and

- The Tribe and the County of Humboldt ("County") have entered a Memorandum of Understanding ("MOU") addressing cooperation in providing emergency services during the COVID-19 epidemic for fiscal year 2020-21, dated July 1, 2020; and
- 7. The MOU contains a limited waiver of sovereign immunity in Section 32; and
- 8. The Business Council has determined that it is in the interest of the Tribe to approve the waiver of sovereign immunity to make the MOU enforceable;

#### NOW, THEREFORE, BE IT RESOLVED as follows:

Pursuant to the Tribal Constitution and General Council Resolution No. 19-38, the Business Council hereby authorizes the limited waiver of the Tribe's sovereign immunity as further provided in Section 32 of the MOU, but does not waive the sovereign immunity or consent to suit on behalf of the Tribe, its subdivisions and business entities or the official immunity of its officers, employees or agents.
