**GOVERNING BODY RESOLUTION FOR AMERICAN SOCIETY FOR THE PREVENTION OF
CRUELTY TO ANIMALS (ASPCA) STRENGTHENING SHELTER ESSENTIALS GRANT**

WHEREAS, the Humboldt County Sheriff's Office desires to participate in the ASPCA Grants for Shelters: Strengthening Shelter Essentials grant opportunity administered by the ASPCA.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt Board of Supervisors hereby:

1. Approves receipt of grant funding from the ASPCA.
2. Authorizes the County Administrative Officer, Sheriff, Undersheriff, or Deputy Director of Financial and Support Services to submit this governing body resolution for the ASPCA Grants for Shelters: Strengthening Shelter Essentials grant opportunity, accept grant funds, and sign any required documents required for participation in the grant program.
3. Appoints the Sheriff, Undersheriff, or Deputy Director of Sheriff's Financial and Support Services as agent to conduct all negotiations, execute and submit all documents including, but not limited to all necessary applications, strategic plans, letters of agreement, contracts, amendments, and reimbursement claims which may be necessary for obtaining financial assistance provided by the ASPCA Grants for Shelters: Strengthening Shelter Essentials funding opportunity.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED that the County of Humboldt agrees to abide by the statutes and regulations governing the Formula Grants Program as well as the terms and conditions of the Grant Amendment set forth by the ASPCA.


