- Future excess revenue will be allocated 50% towards eliminating the Roads negative fund balance until it reaches zero; and*
- The remaining 50% of excess revenue will go towards building a contingency fund until it reaches 16% of annual revenue (approximately \$3.84 million); and*
- Once the negative fund balance is cleared and the contingency fund is fully established, excess revenue will be split 85% to Roads and 15% to HTA; and*
- HTA is permitted to carry over any unspent revenue from year to year pursuant to the timing referenced in Resolution No. 25-91; and*
- HTA may carry forward obligated revenue into the immediate next fiscal year; and*
- HTA must inform the County by April 1 each year of the amount of funding obligated through contracts or purchase orders.*

4. Direct the Clerk of the Board, within 15 days after adoption of the Ordinance, to publish a postadoption summary of the ordinance with the names of the Supervisors voting for and against the Ordinance, and to post in the office of the Clerk of the Board a certified copy of the full text of the adopted Ordinance and amendments along with the names of those Supervisors voting for and against the Ordinance pursuant to Government Code 25124(b)(1); and
5. Direct the Clerk of the Board to sign the "Certification of Governing Body's Action" (Attachment 3), the "Certification of Compliance with Government Code Section 7507" (Attachment 4).


