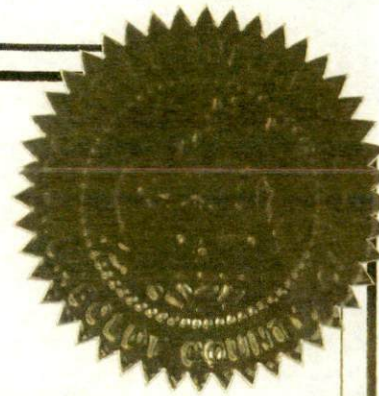

**WHEREAS**, Tim Hershberger began his career with the Humboldt County Sheriff's Office as a Dispatcher I on March 18, 1990; and

**WHEREAS**, Tim was promoted to Sheriff's Dispatcher II on March 17, 1991, to Correctional Officer I on June 19, 1994, to Correctional Officer II on June 18, 1995, and as a temporary Senior Correctional Officer on January 12, 1997; and

**WHEREAS**, on March 9, 1997 Tim was promoted to permanent Senior Correctional Officer, where his primary duties were mid-level supervision and training of new Correctional Officers; and

**WHEREAS**, on August 20, 1998 Tim was assigned the position of Classification Officer, where he was responsible for determining appropriate housing of inmates within the correctional facility; and

**WHEREAS**, on September 30, 2003 Tim became a member and Team Leader on the Specialized Emergency Response Team; and

**WHEREAS**, on November 9, 2005 Tim received a commendation for the development of policy and training of staff for Proposition 69, the collection of DNA from arrestees; and

**WHEREAS**, on October 23, 2006 Tim was assigned the Senior Correctional Officer position in the Sheriff's Work Alternative Program, where he was responsible for the day to day operation of the Sheriff's farm and wood lot, promoting the Humboldt County Sheriff's Office in a positive light by providing inmate work crews working for the betterment of the community; and

**WHEREAS**, on November 9, 2006 Tim was promoted to Acting Sergeant in the Sheriff's Work Alternative Program; and

**WHEREAS**, on June 12, 2007 Tim received a commendation for organizing an inmate work crew for a community Waste Tire Collection Program; and

**WHEREAS**, on January 13, 2008 Tim was promoted to Sergeant where he was responsible for the supervision of Correctional Officers within the Humboldt County Correctional Facility.

**NOW, THEREFORE, BE IT RESOLVED** that the Humboldt County Board of Supervisors, Sheriff Mike Downey and the staff of the Humboldt County Sheriff's Office hereby commends and thanks Sergeant Tim Hershberger for his 26 years of service to the citizens of Humboldt County and wish him and his family a long, productive, and well deserved retirement.
