**ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT ADDING SECTIONS 431-23.5 AND 431-61.0.4 OF CHAPTER 1 OF DIVISION 3 OF TITLE IV OF THE HUMBOLDT COUNTY CODE RELATING TO PARKING RESTRICTIONS IN THE ORICK AND ARCATA AREAS**

The Board of Supervisors of the County of Humboldt hereby ordains as follows:

SECTION 1. Sections 431-23.5 and 431-61.0.4 of Chapter 1 of Division 3 of Title IV of the Humboldt County Code are hereby added as shown on the attached pages.

SECTION 2. This ordinance shall take effect and be in force thirty (30) days from the date of its passage. A summary shall be published at least five (5) days before the date set for adoption and again fifteen (15) days after passage of this ordinance. It shall be published once with the names of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of Humboldt, State of California.

**431-1.General Regulations Concerning Stopping, Standing or Parking Vehicles on Streets in the Unincorporated Areas.**

(a) *Parking on Streets.* When signs are erected and in place giving notice of the manner or of the time limit during which a person may stop, stand or park a vehicle upon any street, or a portion of a street, in the unincorporated area, no person shall stop, stand or park any vehicle on any such street, or part thereof, which is so signed in any different manner or for a period of time longer than is specified by such signs between the hours stated on such signs on any day, except a Sunday or holiday. (Ord. 237, § 1, 6/9/1947)

(b) *Parking off Traveled Way.* All motor vehicles parking upon streets in the unincorporated area shall stop, stand or park off the main traveled way, and it shall be deemed a violation of this chapter to park parallel to, or to the rear of, any line of parked cars (double parking). (Ord. 237, § 2, 6/9/1947; Ord. 2351, § 14, 12/6/2005)

(c) *Temporary Parking Signs.* Whenever the Sheriff shall determine that an emergency traffic congestion is likely to result from the holding of public or private assemblages, gatherings or functions, or for other reasons, he shall have power and authority to order a temporary sign or signs to be erected or posted indicating that the operation, parking or standing of vehicles is prohibited on any street or streets, road or highway, as he shall direct, during the time such temporary sign or signs are in place. Such sign or signs shall remain in place only during the existence of such emergency, and the Sheriff shall cause such sign or signs to be removed promptly thereafter. When such sign or signs are in place giving notice thereof, no person shall operate, park or stand any vehicle contrary to the directions and provisions of such sign or signs. (d) *Penalty.* Pursuant to Vehicle Code § 42001, it shall be unlawful and an infraction for any person to violate any section of this chapter. Every person convicted of such an infraction shall be punished upon a first conviction by a fine not exceeding One Hundred Dollars (\$100.00), and for a second conviction within a period of one (1) year by a fine not exceeding Two Hundred Dollars (\$200.00), and for a third or any subsequent conviction within said period of one (1) year by a fine not exceeding Two Hundred Fifty Dollars (\$250.00). This penalty provision will apply unless another provision is specified by a particular section of this chapter. (Ord. 432, § 4, 5/8/1962; Ord. 2351, § 14, 12/6/2005)

**431-2.Accessible Parking Spaces for Persons with Disabilities.**

(a) *Use of Accessible Parking Spaces (Parking for Persons with Disabilities).* Persons using parking spaces designated for persons with disabilities shall comply with the following:

(1) No person shall park or stand any vehicle in a parking space designated for accessible parking unless said vehicle bears a special license plate or displays a special placard issued under the provisions of Section 5007, 22511.55 or 22511.59 of the California Vehicle Code. (Ord. 2339, § 1, 3/22/2005)

(2) Parking spaces designated for accessible parking shall be operative twenty-four (24) hours a day, Sundays and holidays included.

(3) Parking spaces designated for accessible parking are subject to any temporary parking prohibitions established by the County. (Ord. 1204, § 1, 3/7/1978)

(b) *Identification.* Accessible parking spaces shall be identified pursuant to the provisions of §§ 22511.7 and 22511.8 of the California Vehicle Code. Identification shall also comply with all federal, state and local accessibility laws, standards, ordinances and regulations. (Ord. 1204, § 5, 3/7/1978)

(c) *Off-Street/Publicly Owned Facilities.* The Director of Public Works shall establish parking spaces designated for accessible parking in publicly owned, leased or controlled off-street parking facilities. (Ord. 1204, § 3, 3/7/1978; Ord. 2314, § 1, 2/24/2004)

(d) *Location of Accessible Parking Spaces.* The following locations shall be marked as accessible parking:

(1) *Maple Street (County Road 6B125).* From Post Mile 0.087 to Post Mile 0.091 (P.K. 0.140 to P.K. 0.146). (Ord. 2339, § 1, 3/22/2005)

(2) *Redwood Drive (County Road 6B105).* From Post Mile 2.722 to Post Mile 2.727 (P.K. 4.381 to P.K. 4.389). (Ord. 2640, § 2, 2/11/2020)

**431-4.Parking on Alliance Road.**

The parking of vehicles is hereby prohibited at all times on the following portions of Alliance Road (County Road No. F4L095):

(a) The west side thereof from its intersection with Stewart Avenue to a point 50 feet (15.24 meters) northerly therefrom.

(b) The west side thereof from a point opposite the center of Hilfiker Avenue to a point 100 feet (30.48 meters) north of the north line of Simpson Mill Road (County Road No. 4L570).

(c) The east side thereof from its intersection with Hilfiker Avenue to a point 100 feet (30.48 meters) north of the north line of Simpson Mill Road. (Ord. 437, § 1, 8/14/1962)

**431-5.Parking at 17th Street and Nedra Avenue/Myrtle town.**

The parking of vehicles six (6) feet and greater in height is hereby prohibited at all times for a distance of 100 feet on both legs of the southwest corner of 17th Street (County Road No. 3D720) and Nedra Avenue (County Road No. 3K730). (Ord. 1923, § 1, 1/15/1991)

**431-7.Parking on Arbutus Street.**

The parking of vehicles is hereby prohibited at all times on the south side of Arbutus Street (County Road No. 3K250) from Post Mile 0.16 for a distance of 50 feet west to Post Mile 0.17 (P.K. 0.26 to P.K. 0.27). (Ord. 2489, § 4, 10/2/2012)

**431-8.Parking at Arcata-Eureka Airport.**

The parking of vehicles is hereby prohibited at all times on the following portions of the roads at Arcata-Eureka Airport:

(a) Along both sides of Airport Loop Road from Airport Road, except as otherwise described in subsequent subsections.

(b) Along both sides of Baadsgaard Avenue, from its intersection with said Boeing Avenue to its intersection with Airport Loop Road. (Ord. 2351, § 14, 12/6/2005)

(c) In the parking lots lying north, south and west of the Terminal Building, except as said parking lot is designated by the Director of Aviation for the County for car rental agency parking, handicapped parking, utility maintenance vehicle parking, executive aircraft passenger loading and unloading, Federal Aviation Administration personnel, Sheriff's Department personnel, airport employee parking and hotel/motel courtesy vehicle parking, or except as such parking is authorized and allowed by concessionaires operating a fee parking service pursuant to a concession agreement entered into between concessioner and County.

(d) Along both sides of Airport Road (County Road No. C4M200) between Post Mile 0.21 and Post Mile 0.72 (P.K. 0.33 to P.K. 1.14), and this parking prohibition shall be enforced twenty-four (24) hours a day, seven (7) days a week.

(e) Certain signed curb spaces of the roads at Arcata Airport are hereby designated as loading or unloading of passengers or baggage from buses, taxicabs, or limousines engaged as common carriers or courtesy buses engaged by hotel and motel establishments. Vehicles using such spaces may not be left unattended. (Ord. 2351, § 14, 12/6/2005)

**431-12.Parking on Beach Road.**

The parking of vehicles is hereby prohibited on Beach Road in Redway (County Road No. 6B030) from the hours of 9:00 p.m. to 6:00 a.m. (Ord. 453, § 1, 4/16/1963)

**431-13.Parking on Bald Hills.**

The parking of vehicles is hereby prohibited at all times on Bald Hills Road (F4R300) between Post Mile 2.65 and Post Mile 2.72 (P.K. 4.26 to P.K. 4.38) and Post Mile 12.051 to Post Mile 12.081 (P.K. 19.394 to P.K. 19.442) on both sides of the roadway. (Ord. 2460, § 1, 8/30/2011; Ord. 2701, § 5, 12/6/2022)

**431-14.Parking on Blue Lake Boulevard.**

The parking of vehicles is hereby prohibited at all times on the east side of Blue Lake Boulevard (County Road No. F5L016) from Post Mile 0.88 to Post Mile 0.91 (P.K. 1.39 to P.K. 1.44). (Ord. 1250, § 1, 8/15/1978)

**431-14.1.Parking on Boeing Avenue.**

(b) on the west side between Post Mile 0.93 to Post Mile 0.97 (P.K. 1.47 to P.K. 1.54) (Ord. 1763, § 1, 12/16/1986)

**431-16.Parking on Briceland Thorn Road.**

(a) The parking of vehicles is hereby prohibited at all times on the west side of Briceland Thorn Road (County Road No. C5A010) between Post Mile 1.90 and Post Mile 1.92 (P.K. 3.05 to P.K. 3.09). (Ord. 684, § 1, 7/8/1969)

(b) The parking of vehicles is hereby prohibited at all times on the north side of the Briceland Thorn Road (County Road No. F5A010) between Post Mile 10.53 and Post Mile 10.56 (P.K. 16.94 to P.K. 16.99). (Ord. 983, § 1, 5/28/1974)

(c) The parking of vehicles is hereby prohibited at all times on Briceland Thorn Road between the hours of 8:00 a.m. to 3:00 p.m., Monday through Friday, from September 1st to June 15th of each year, P.M. 12.34 to P.M. 12.35 (P.K. 19.86 to P.K. 19.88). (Ord. 1834, 6/7/1988; Ord. 2444, § 2, 2/15/2011)

(d) The parking of vehicles is hereby prohibited at all times on the north side of the Briceland Thorne Road (County Road No. C5A010) between Post Mile 12.32 and Post Mile 12.34 (P.K. 19.83 to P.K. 19.86). (Ord. 2444, § 2, 2/15/2011)

**431-20.Parking on Buhne Drive.**

The parking of vehicles is hereby prohibited at all times on the east side of Buhne Drive (County Road No. 3J811) from the intersection of Perch Street at Post Mile 0.312 to Post Mile 0.320 (P.K. 0.502 to P.K. 0.515). (Ord. 784, § 1, 8/24/1971; Ord. 2661, § 1, 12/8/2020)

**431-20.1.Parking on Portion of Butler Valley Road.**

The parking of vehicles is hereby prohibited at all times on the north side (westbound) of Butler Valley Road, County Road #F3J031, from PM 7.55 to PM 7.95 (PK 12.16 to PK 12.80). (Ord. 2125, § 1, 7/23/1996)

**431-21.Parking on California Street.**

The parking of vehicles is hereby prohibited at all times on the east side of California Street (County Road No. 2G065) in the Ferndale area from P.M. 0.00 to P.M. 0.38 (P.K. 0.00 to P.K. 0.60). The restriction provided by this subsection shall be applicable only on those days devoted to the Humboldt County Fair, and when appropriate signs giving notice that parking is restricted have been posted at intervals not to exceed 500 feet along said east side of California Street (County Road No. 2G065). (Ord. 1497, § 1, 12/1/1981)

**431-21.1.Parking on Cedar Street.**

The parking of vehicles is hereby prohibited at all times on the east side of Cedar Street (County Road No. 3K280) from Post Mile 0.31 to Post Mile 0.33 (P.K. 0.50 to P.K.0.53). (Ord. 2147a, § 1, 5/27/1997)

**431-21.5.Parking on Central Avenue.**

(a) The parking of vehicles is hereby prohibited at all times on the west side of Central Avenue (County Road No. A4L800) between Post Mile 2.20 and Post Mile 2.27 (P.K. 3.52 and P.K. 3.63).

(b) The parking of vehicles is hereby prohibited at all times on the east side of Central Avenue (County Road No. A4L800) between Post Mile 2.103 and Post Mile 2.155 (P.K. 3.384 and P.K. 3.468). (Ord. 2386, § 4, 5/1/2007; Ord. 2640, § 3, 2/11/2020)

**431-22.Parking on Chambers Road.**

The parking of vehicles is hereby prohibited on both sides of Chambers Road (County Road No. 2D020) between the hours of 7:00 a.m. and 5:00 p.m., Monday through Friday, between P.M. 0.00 to P.M. 0.03 (P.K. 0.00 to P.K. 0.05). The restriction provided herein shall not be applicable on Saturdays, Sundays or legal holidays. (Ord. 1497, § 2, 12/1/1981)

**431-23.Parking on Clam Beach Drive.**

The parking of vehicles is hereby prohibited on the east side of Clam Beach Drive (County Road No. 4M260) from P.M. 0.01 to P.M. 0.93 (km 0.02 to km 1.47). (Ord. 1700, § 1, 7/30/1985)

**431-23.1.Parking on Cod Street.**

The parking of vehicles is hereby prohibited at all times on the north side of Cod Street (County Road No. 3J860) from Post Mile 0.00 to Post Mile 0.02 (P.K. 0.00 to P.K. 0.03). (Ord. 2147a, § 2, 5/27/1997)

**431-23.2.Parking on Cypress Street.**

The parking of vehicles is hereby prohibited on the north side of Cypress Street (County Road No. 3K270) from Post Mile 0.12 to Post Mile 0.16 (P.K. 0.26 to P.K.0.30) and on the south side of Cypress Street from Post Mile 0.08 to Post Mile 0.14 (P.K. 0.13 to P.K. 0.22) and Post Mile 0.16 to Post Mile 0.17 (P.K. 0.26 to P.K. 0.27) between the hours of 8:00 a.m. and 4:00 p.m. on school days. (Ord. 1038, § 1, 7/29/1975; Ord. 2245, 5/1/2001)

**431-24. Parking on Elk River Road.**

(a) The parking of vehicles on Elk River Road (County Road No. F3J300) is hereby prohibited between the hours of 10:00 p.m. and 5:00 a.m. from Post Mile 0.0 to Post Mile 0.02 (P.K. 0.0 to P.K. 0.03).

(b) The parking of vehicles is hereby prohibited on both sides of Elk River Road (County Road No. F3J300) from Post Mile 1.314 to Post Mile 1.490 (P.K. 2.114 to P.K. 2.397) at all times. (Ord. 2337, § 2, 1/18/2005; Ord. 2633, § 3, 7/2/2019)

**431-28. Parking on Empire Avenue.**

(a) The parking of vehicles is hereby prohibited from the hour of 8:00 a.m. to the hour of 4:00 p.m. on the north side of Empire Avenue (County Road No. 6B065) between Post Mile 0.24 and Post Mile 0.27 (P.K. 0.39 to P.K. 0.43). The restriction provided herein shall not be applicable on Saturdays, Sundays or legal holidays and shall be applicable only from the 1st day of September until the 15th day of June of any year. (Ord. 890, § 1, 11/8/1972; Ord. 2506, § 3, 9/10/2013)

(b) The parking of vehicles is hereby prohibited at all times on the east side of Empire Avenue (County Road No. 6B065) from Post Mile 0.047 to Post Mile 0.143 (P.K. 0.076 to P.K. 0.230). (Ord. 2506, § 3, 9/10/2013)

**431-32. Parking on F Street.**

(a) The parking of vehicles is hereby prohibited at all times on the easterly side of F Street (County Road No. A3J590) from the southerly curb line of Oak Street (County Road No. C3K190) Post Mile 0.41 to Post Mile 0.43 (P.K. 0.66 to P.K. 0.69). (Ord. 710, § 1, 3/24/1970; Ord. 2513, § 1, 2/4/2014)

(b) The parking of vehicles is hereby restricted between the hours of 8:00 a.m. to 9:30 a.m. and 3:00 p.m. to 4:00 p.m. on the easterly side of F Street (County Road No. A3J590) between P.M. 0.33 to P.M. 0.34 (P.K. Point 0.52 to P.K. Point 0.54) for the purpose of loading and unloading ambulatory disabled adults. (Ord. 1798, § 2, 5/26/1987)
