ORDINANCE AMENDING TITLE III, DIVISION 11, CHAPTER 1 OF HUMBOLDT COUNTY CODE to add Section 3111-14 - Local Responsibility Area Fire Hazard Severity Zones; adopting the recommended Fire Hazard Severity Zones within the Local Responsibility Area.

ORDINANCE NO. 2763

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1. PURPOSE OF FIRE SAFE REGULATIONS AMENDMENTS.


Title III, Division 11, Chapter 1 of the Fire Safe Regulations, adding Section 3111-14 and adopting the Fire Hazard Severity Zones within the Local Responsibility Area, as identified by the State Fire Marshal. The intent is to comply with California Government Code Section 51179.

SECTION 2. Local Responsibility Area Fire Hazard Severity Zones

Section 3111-14, regarding Local Responsibility Area Fire Hazard Severity Zones in Title III, Division 11, Chapter 1 of the Humboldt County Code, is hereby adopted as follows (additions to text are shown as underlined text):

3111-14. Local Responsibility Area Fire Hazard Severity Zones.

The Local Responsibility Area (LRA) Fire Hazard Severity Zones shown in the map below are designated as Moderate, High, and Very High Severity as recommended by the California Department of Forestry and Fire Protection pursuant to Government Code Section 51178. The High and Very High Severity Zones are subject to Chapter 7A of the California Building Code.
