**WHEREAS**, in April, 2017, Genevieve Regli was selected as a new California Future Farmers of America (FFA) state officer. Genevieve is only the second woman from Ferndale elected in California FFA's 89 year history; and

**WHEREAS**, Genevieve was voted in as California State FFA Secretary and joined five other newly elected state officers on a year-long journey, traveling throughout California representing more than 85,000 student members who belong to the leadership development organization; and

**WHEREAS**, Genevieve's election by the voting delegates at the 89<sup>th</sup> annual California FFA State Conference was at the conclusion of six days of competition, speeches, voting, and after days of vigorous interviews; and


**WHEREAS**, Ferndale state and national Officer Peter Giacomini, elected to represent California in 1973, noted how much harder it is for kids from the North Coast Region to get elected, simply because it is the smallest region in the state, and there are so many more challenges and obstacles to overcome.
