I have not been helped. In fact, as a social worker living in Fortuna I have witnessed little outreach to adults without housing, particularly those with substance use challenges. Outreach means more than offering services, it means being present in the community and creating relationships with people in need to create trust so people will obtain care and access services.

### Question 3

I would like to see a drop in/wellness center created in Fortuna to bring services to Fortuna residents.

Our trailer park on Fortuna Blvd is not served by the city of Fortuna in terms of ensuring the health and welfare of adults and youth. Children live amid gunfire at times. Our local Healthy Start does a great job trying to serve these families and individual adults in poverty but cannot remedy the lack of systemic supports that cause the spiral in that location.

This has resulted in corporate and out of county ownership of new cannabis production operations.

I understand the Humboldt Patient Resource Ctr is not pursuing this community education for political reasons involving stigma, but our county could recognize the positive benefits of cannabis and work with health care providers and cannabis businesses to teach community how to make their own products (i.e. salves and oils) to support our health. I believe this would have a direct impact on reduction of opioid use.

### Question 3

Having spent 25 years in Humboldt County, I see the increasing drug and crime culture as the largest issue for Humboldt County. It's one of our

own making through good intentions. Humboldt does not have a homeless problem. We have a drug, addiction, mental health, and crime problem which are interlinked (as you know). These problems have increased because the issue has been mis-branded as a housing or homeless problem. I know there's a lot of money earmarked to "combat the homeless epidemic" in Humboldt. But, just as Seattle is waking up to the realization that it's not a "homeless" issue, so should we. You can't throw money and programs at the issues and wish them away. If that was the case, there shouldn't be a homeless problem.

I was homeless in Redding many years ago. I do know what it means to be homeless... I do know what it takes to get back on my feet. Seattle is beginning to wake up. So should we. Having lived it, I don't believe removing the stigma of bad behavior will make the issue any better. Why normalize the behavior and make it acceptable when so many people (including the perpetrator) are harmed by it? We need to decrease the handouts and increase the true hand ups. I have compassion for those struggling and I want them to succeed. So much so, I'm willing to let them fail so they can learn to do for themselves. Because, they won't get out of the cycle until they want to on their own. And, yes, I know the line you dance on and believe the County has been dancing on the wrong side of the line.

One of my sons got involved in the local drug culture and subsequently the local gang and criminal underground. He has told me stories of crimes he committed for his drug of choice and the lengths (or depths) he went to in order to get his next fix. After serving time in jail for dealing and two separate recovery programs, he's out and a productive member of society. Sure, he still has challenges. But, he's no longer a plague on the community (his own words). His says the only thing that got him out was his own motivation to do so and the handouts (from family, friends, and organizations) extended and facilitated his drug use cycle. For him (and many others), it began with cannabis.

Free law enforcement to do their job. Take the handcuffs off of the local police and governing agencies. Grant them the funding to enforce the laws and keep law abiding citizens safe. Reduce the revolving door in and out of the jail. I know State laws have played a huge part in this. But, there are things we can do on a local level to reduce the number of people "circling the drain". Make being "homeless" in Humboldt harder and less attractive, not easier. We attract quite a few users through our programs, existing drug culture, and relatively mild weather (the last is out of our control). I know these changes would impact our funding and redirect resources. But, it would benefit the community and promote safety.

I've been victimized 5 times in the last 5 years and nothing was done except for a police report. I was victimized 0 times in the 20 years prior and lived 5 of those years in the same residence I'm in now. Relabeling the crimes as petty doesn't mean a crime didn't happen and that it wasn't bad (another change by the state and voters). Let's stop the flow of drugs and give people a hand up as they make the conscious decision to recover. I know, there's that line again. Let's dance on the right side for a while and see if we can lift up everyone... all of Humboldt.

AT&T has not delivered (despite several published promises to do so) and it may be time to put even more pressure on them to do so.

As for a "Healthy Environment", fix our existing roads first. You can examine "what if" scenarios on potential sea level changes later. But, I don't believe it's prudent to place a large emphasis on what would be a relatively slow change in sea levels (extremist opinions notwithstanding). Bring back responsible logging programs and support traditional industry/businesses.

Stop following the political winds and be responsible with the public trust. Too many times politics has driven our practices because of the hysteria. The County has a fiduciary responsibility to act in a manner that's right for the community. This may run counter to the desires of some vocal pundits and groups. Resist the pressure and bandwagon tendencies. Do better with what you have been entrusted with and then look to expand upon it.

According to the US Census, Humboldt County is near the top in the entire US for number of homes that heat with wood. This is a significant public health issue in our region, but has been left out of the discussion. This also ties into housing issues, as it relates to heating insecurity and fuel poverty.

Researchers elsewhere have estimated that the average externalized health-related costs of each wood stove can average around \$3,000 a year, and that over a whole community the externalized costs of wood heating can reach several million.

Neighbors of wood-burning households have been shown in research to experience air pollution levels that can be 100 times higher, or more, than what is reflected by community air monitoring.

Many people here also use their wood stoves as a trash disposal method, which adds additional carcinogens to the air we breathe. NCUAQMD makes it clear that they will not enforce regulations against people burning garbage in wood stoves. Among other things, we need to make garbage service mandatory throughout the county.

A recent peer-reviewed study found that people who heat with wood, as well as their neighbors, are more likely to develop dementia (in agreement with several other studies on fine particle air pollution more generally). Wood smoke pollution from wood heating has also been linked to increased heart attack risk in seniors. Combustion-derived fine particle pollution has been linked to neurodevelopmental harm in children in multiple studies. But that's just the tip of the iceberg.

Fine particle air pollution has been compared to lead pollution — there is no harmless level of exposure. Even low amounts that are considered "safe" under current regulatory standards have been linked in numerous studies to serious health effects and premature deaths.

We will never make much progress towards a "Healthy and Safe Community" without confronting our wood burning problem. A 1995 draft report by the NCUAQMD stated, "The need for improved wood burning regulations is necessary to protect human health." Yet no action has been taken on this in the nearly quarter of a century since. When will this become part of the discussion?

### Question 4

In regards to item 2.4B, implementing the targets in the CWPP: The CWPP target to promote more wood heating in Humboldt County needs to be discarded. It is frankly irrational from a fire safety point of view, and would be extremely damaging from a public health point of view.

The impact on neighbors from residential wood heating is increasingly being seen as an environmental justice and human rights issue, analogous to forced exposure to secondhand tobacco smoke. A modern EPA-certified wood stove used with perfectly dried wood in laboratory-perfect, controlled conditions (which are virtually impossible to replicate in real-world settings) emits the fine particle pollution equivalent of the exhaust from 18 modern diesel cars, or 6 diesel semis. The county should not be encouraging this kind of harm for more people, based on misguided reasoning that is not supported by evidence.
