

ORDINANCE NO. 1114AMENDING ORDINANCE NO. 519
TO REZONE PROPERTY IN HONEYDEW AREA

The Board of Supervisors of the County of Humboldt do ordain as follows:

SECTION 1. Section 304 of Ordinance No. 519 is hereby amended by rezoning the following area from an F-R-B-5 (40-acre minimum) Zone to the following described zones:

A-G-B-6 ZONE

BEGINNING at the southeast corner of the southwest quarter of the southwest quarter of Section 31, Township 2 South, Range 1 East, Humboldt Base and Meridian;
 thence east 1100 feet;
 thence south 1300 feet;
 thence east 400 feet to center of Mattole River;
 thence southwest along the center of Mattole River 1700 feet;
 thence west 1650 feet;
 thence north 18 degrees west 1600 feet;
 thence north 04 degrees west 1050 feet;
 thence west 1850 feet to center of Mattole Road alignment;
 thence northeasterly along the centerline of Mattole Road 2650 feet to Old Hindley Ranch Road (private road);
 thence southeasterly along Old Hindley Ranch Road (private road) 1500 feet to center of Applewood Road (private road);
 thence southeasterly along the centerline of Applewood Road (private road) 700 feet;
 thence north 57 degrees east 500 feet to point of beginning.

A-E-B-6 ZONE

BEGINNING at the southeast corner of the southwest quarter of the southwest quarter of Section 31, Township 2 South, Range 1 East, Humboldt Base and Meridian;

thence south 57 degrees west 500 feet to centerline of Applewood Road (private road);
thence northwesterly along the centerline of Applewood Road (private road) 700 feet to centerline of Old Hindley Ranch Road (private road);
thence northwesterly along the centerline of Old Hindley Ranch Road (private road) 1400 feet to centerline of Mattole Road;
thence northwesterly along the centerline of Mattole Road 3300 feet;
thence east 300 feet;
thence north 06 degrees east 400 feet;
thence north 33 degrees east 600 feet;
thence north 80 degrees east 250 feet;
thence north 24 degrees east 450 feet;
thence east 150 feet to the west line of Section 31;
thence northerly along the west line of Sections 30 and 31, 2850 feet;
thence south 86 degrees east 2100 feet to centerline of Mattole Road;
thence northeasterly along the centerline of Mattole Road 12,100 feet;
thence east 660 feet;
thence south 03 degrees west 2800 feet;
thence west 440 feet;
thence north 200 feet to centerline of Brinks Drive (private road);
thence westerly and southerly along the centerline of Brinks Drive (private road) 2300 feet to south line of Section 28;
thence westerly along the south line of Sections 28 and 29, 1800 feet;
thence south 1500 feet;
thence north 80 degrees west 200 feet to centerline of Elsa Lane (private road);
thence westerly along the centerline of Elsa Lane (private road) 1000 feet;
thence north 80 degrees west 4000 feet to centerline of Heidi Lane (private road);
thence westerly along the centerline of Heidi Lane (private road) 550 feet;
thence north 80 degrees west 600 feet;
thence south 37 degrees west 850 feet;
thence south 850 feet;
thence north 82 degrees west 1000 feet;
thence south 3800 feet to point of beginning.

Said zones describe territory shown on Zoning Maps H-42, H-43, I-42, I-43 and J-42.


SECTION 2. This ordinance becomes effective thirty (30) days after the date of its enactment.
