Dear Humboldt County Supervisors,

It is not difficult to see that there are major agendas behind COVID 19. You do NOT have to be a doctor, or "health expert" to get educated and learn the truth about the issues associated with it. You just have to have an open mind, and be willing to look beyond the mainstream narratives.

They decrease oxygen intake and increase toxin inhalation. They shut down the immune system and increase virus risk. Sheltering in place and wearing masks do not protect us... they do the opposite!

I grew up in Humboldt, 4th generation here on my Dad's side... maiden name Dalton. There has always been somewhat of a self-sufficient mindset here, and we've always survived through economic downturns. I always loved the fact that we were still part of the "Wild West," and lived outside the box. Look at what's happening to our County! The lockdowns and mandatory masks are stripping us of our personal freedoms and livelihoods. We're losing everything!

My name is Zach Cahill and I am a Humboldt County resident that believes that it is time to reopen our county.

Schools have been closed, businesses have been shut down (some permanently), our youths extracurricular activities have been cancelled, essential fundraising events will not happen during a time of statewide budget cuts (i.e. the CR football program getting cut due to budget cuts from an induced economic shutdown, just as one example), important celebrations such as graduations, weddings, funerals, local fairs etc. have been either prohibited or cancelled. I could go on, but you all get the point.

There was a time when these preventative measures may have seemed appropriate based off of the unknown threat that COVID-19 held, but now that we are three months into our classified pandemic, what has happened and where are we at today?
