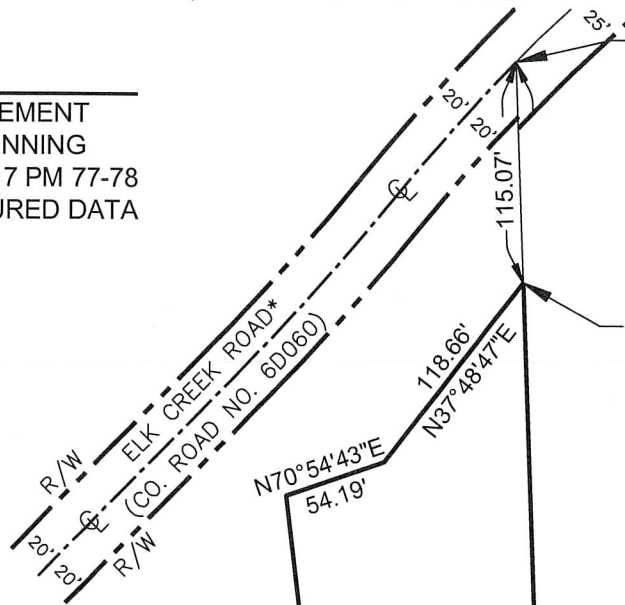
PORTION NW 1/4 SEC. 15, T2S, R3E, H.M.

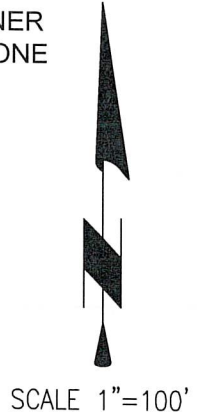
