<p>The Humboldt County Sheriff's Office is responsible for law enforcement services to over 75,000 people within Humboldt County, over half its population. Humboldt County is incredibly rural and stretches over four thousand square miles. The coronavirus pandemic has upended standard operating procedure by limiting the way staff can safely interact with each other and the public they serve. As essential workers in this global crisis, changes to procedure to reduce interpersonal contact could save untold numbers of citizens from contracting the disease and potentially suffering fatal consequences. These modifications are time-sensitive and result in costs that were not anticipated when the department's budget was drafted. The CESF Grant funds will be used to purchase necessary equipment for ongoing law enforcement and community response activities in a safe and prudent manner.</p>
