GOVERNING BODY RESOLUTION FOR FISCAL YEAR 2025, 2026, AND 2027 BETWEEN HUMBOLDT COUNTY SHERIFF'S OFFICE AND THE DRUG ENFORCEMENT ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF JUSTICE DOMESTIC CANNABIS ERADICATION/SUPPRESSION PROGRAM

WHEREAS the Humboldt County Sheriff's Office desires to receive funding and/or operational support in conducting marijuana eradication and suppression efforts from the Drug Enforcement Administration of the United States Department of Justice Domestic Cannabis Eradication/Suppression Program.

WHEREAS, procedures established by Federal statutes require the Applicant's Governing Body to certify by resolution the approval to receive grant funding from the Drug Enforcement Administration (DEA) of the United States Department of Justice.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt Board of Supervisors hereby:

1. Approves receiving of grant funding from the Drug Enforcement Administration of the United States Department of Justice Domestic Cannabis Eradication/Suppression program.
2. Appoints the Sheriff, Undersheriff, or Deputy Director of Sheriff's Financial and Support Services as agent to conduct all negotiations, execute and submit all documents including, but not limited to all necessary applications, strategic plans, letters of agreement, contracts, amendments, and reimbursement claims which may be necessary for obtaining federal financial assistance provided by the Drug Enforcement Administration of the United States Department of Justice Domestic Cannabis Eradication/Suppression program for the grant Fiscal Years 2025, 2026, and 2027.


