RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING ACCEPTANCE OF GRANT FUNDING MADE AVAILABLE BY THE CALIFORNIA DEPARTMENT OF INSURANCE THROUGH THE WORKERS' COMPENSATION INSURANCE FRAUD PROGRAM

WHEREAS, the Humboldt County District Attorney's Office has partnered with both the Del Norte and Trinity County District Attorney's Offices for the purpose of developing and operating a regional Insurance Fraud Unit; and

WHEREAS, the regional Insurance Fraud Unit is responsible for investigating and prosecuting workers' compensation fraud, and providing community outreach regarding identification and reporting of insurance fraud in all three regional areas; and

WHEREAS, on April 23, 2024, the Humboldt County District Attorney's Office, submitted an application for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program in order to continue operating the regional Insurance Fraud Unit during fiscal year 2024-2025; and

WHEREAS, on July 9, 2023, the California Department of Insurance awarded the Humboldt County District Attorney's Office grant funding through the Workers' Compensation Insurance Fraud Program in the amount of Two Hundred Forty-One Thousand Nine Hundred Thirty-Two Dollars (\$241,932.00) to allow for the continued operation of the regional Insurance Fraud Unit during fiscal year 2024-2025; and

WHEREAS, the Humboldt County District Attorney's Office, will reapply for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program in order to continue full operation of the regional Insurance Fraud Unit throughout fiscal year 2025-2026.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The application for grant funding made available by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program submitted by the Humboldt County District Attorney's Office on April 23, 2024 is hereby ratified.
- 2. The Humboldt County District Attorney, or a designee thereof, is hereby authorized to enter into, execute and deliver a State of California Standard Agreement for the amount of Two Hundred Forty-One Thousand Nine Hundred Thirty-Two Dollars (\$241,932.00), and any future amendments thereto, along with any and all other applications, agreements, certifications, attestations and documents required or deemed necessary or appropriate to evidence and secure the grant funding awarded by the California Department of Insurance through the Workers' Compensation Insurance Fraud Program.
- 3. The Humboldt County District Attorney's Office shall not use any of the grant funds awarded by the California Department of Insurance through the Worker's Compensation Insurance Fraud Program to supplant expenditures controlled thereby.
- 4. It is agreed that any liability arising out of the performance of the Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the Humboldt County District Attorney's
