**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IMPLEMENTING THE ADOPTION OF THE COUNTY COUNSEL LAW CLERK JOB CLASSIFICATION AND SPECIFICATION IN THE DESIGNATED MANAGEMENT AND CONFIDENTIAL EMPLOYEES AND ADOPTING THE 2025-02-02 COMPENSATION SCHEDULE.**

**WHEREAS**, the Board of Supervisors of the County of Humboldt ("County") is authorized by Section 25300 of the California Government Code to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

**WHEREAS**, on January 4, 2022, the Board of Supervisors adopted Resolution No. 22-19, providing for the implementation of the 2022-2024 Compensation Plan for Designated Management and Confidential Employees; and

**WHEREAS**, the Board of Supervisors intends to amend the 2022-2024 Compensation Plan for Designated Management and Confidential Employees; and

**WHEREAS**, California Employees Retirement System ("CalPERS") requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County Board of Supervisors hereby adopts the attached job classification and specification of County Counsel Law Clerk (M&C) (class 0597, salary range 461, bargaining unit 009) into the classification plan effective February 2<sup>nd</sup>, 2025.
2. The Humboldt County Board of Supervisors hereby adopts the attached 2025-02-02 Compensation Schedule effective February 2<sup>nd</sup>, 2025;
3. The Humboldt County Board of Supervisors hereby adopts the attached resolution approving the amendments to 2022-2024 Compensation Plan for Designated Management and Confidential Employees effective February 2<sup>nd</sup>, 2025; and
