RESOLUTION NO. 25-173

RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS ESTABLISHING THE FISCAL YEAR 2025-2026 APPROPRIATIONS LIMITS FOR SPECIAL DISTRICTS GOVERNED BY THE HUMBOLDT COUNTY BOARD OF SUPERVISORS

WHEREAS, Article XIII B of the California Constitution, added by Proposition 4 (November 1979) and subsequently amended by Proposition 98 (November 1988) and Proposition 111 (June 1990) provides that the state and each local government shall establish an annual Appropriations Limit; and

WHEREAS, Section 8(e)(2) of Article XIII B of the California Constitution requires the state and each local government to select the change in cost of living methodology each year by recorded vote of the governing body; and

WHEREAS, the percentage change in the California per capita income provides a higher change in Cost of Living index than the change in the local assessment roll from the preceding year due to the addition of local nonresidential new construction; and

WHEREAS, the Humboldt County Auditor-Controller's Office has prepared the calculation and made the same available for public review during business hours for fifteen (15) days prior to the November 18, 2025, Humboldt County Board of Supervisors meeting in compliance with California Government Code Section 7910(a); and

WHEREAS, the Humboldt County Clerk of the Board's Office published notice on or before October 23, 2025 of the location where the applicable statements were available for public inspection.

NOW, THEREFORE, BE IT RESOLVED that the Special Districts governed by the Humboldt County Board of Supervisors select the percentage change in California per-capita income and the change in the population within Humboldt County combined with population growth in all counties having borders contiguous to the County of Humboldt; and

BE IT FURTHER RESOLVED that the following fiscal year 2025-2026 Appropriations Limits for the Special Districts governed by the Humboldt County Board of Supervisors are hereby adopted:



BE IT FURTHER RESOLVED that any judicial action or proceeding to attack, review, set aside, void or annul the fiscal year 2025-2026 Appropriations Limits established by this resolution shall be commenced within forty-five (45) days from the date of this resolution in accordance with Division 9 of Title 1 of the California Government Code.
