## RESOLUTION

## OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT

WHEREAS, Steve Justus was born on August 6, 1947 in Crescent City, California and moved permanently to Humboldt County, California in 1980; and

**WHEREAS**, Steve served in the United States Army from January 1967 until December 1970 and was wounded in action while serving in Vietnam and awarded the Purple Heart and received an honorable discharge as a Sergeant; and

WHEREAS, Steve served as the Director of Bay Old Boys from 1974 through 1980, rehabilitating juvenile delinquent teenagers from all over the state of California; and

WHEREAS, from July 1, 1995 until June 30, 1996 Steve served as President of the Mad River Rotary Club in McKinleyville, California, and in 2000 was ordained a deacon in the Catholic Church serving with distinction in the parish of Sacred Heart Church; and

WHEREAS, in 2008, Steve was instrumental in introducing several important projects to the Rotary Club of Eureka, one of which was the Safe Blood Africa Project, which provided blood bank refrigerators to hospitals in Nigeria. The project also provided centrifuges, donor beds, two bloodmobiles and other equipment needed for transfusions, as well as training of staff both in Nigeria and in the United States; and

WHEREAS, Steve also spearheaded the rehabilitation and modernization of Eureka High School's Bud Clooney Baseball Field and a program to feed some of Humboldt County's children with Back Packs for Kids. A Program which provides income-eligible children with a back pack of kid-friendly food on Fridays during the school year. Each bag contains enough food for breakfast, lunch, and dinner for two days; and

WHEREAS, from July 1, 2009 until June 30, 2010 Steve served as Rotary Assistant District Governor for Northern California, District 5130, and in March 2009, started the process of organizing a Lost Coast Rotaract Club in order to give young adults an opportunity to learn about Rotary and serve their community; and

WHEREAS, in April 2011, Steve co-founded North Coast Honor Flight, which has taken 417 World War II and Korean veterans back to Washington, D.C. to see the memorials that were created in their honor.

NOW THEREFORE, BE IT RESOVED that the Humboldt County Board of Supervisors wishes to honor Steve Justus for all his contributions to Humboldt County, and wishes him continued health and happiness.
