On behalf of the Humboldt County Board of Supervisors I am writing to express our support for Inyo Networks request for funding from the California Advanced Services Fund (CASF) for a middle mile and last mile project along Hwy 299 in Humboldt and Trinity Counties. The project is known locally as the "Digital 299 Broadband Project".

Our Board has long been committed to promoting broadband deployment in unserved and underserved areas throughout our region and recognizes the extreme importance of broadband in rural communities. Thus, building middle and last mile along highway 299 is a high priority project for this region and we are excited that Inyo Networks, as a certificated carrier and who has formerly worked successfully with the CASF program on Digital 395, is willing to invest in the area.

In addition to the Highway 299 corridor, the proposed Middle Mile network will include a lateral along Highway 3 into Hayfork and north on Lewiston Road to the community of Lewiston. To the west, in Humboldt County, a lateral is planned to provide services along Highway 101 into the community of Trinidad.

The proposed last mile networks will support gigabit levels of broadband, voice and video services to unserved and underserved residential and business customers and Community Anchor Institutions. The project proponents will not target communities where service providers already exist and meet requirements established by the California Public Utilities Commission (CPUC).
