**Description of Nature, Purpose, and Beneficiaries of Project:**

The project is a transfer of real property from the County to the City of Fortuna (City). The City proposes to utilize the parcels as part of the Rohner Creek Flood Control, Habitat, and Seismic Improvement Project and ongoing management and maintenance responsibilities. A culvert runs under 12th Street between the two parcels. On August 4, 2014, the City filed a Notice of Determination for Mitigated Negative Declaration with the State Clearinghouse (SCH No. 2014062010). Beneficiaries include property owners within the project area who will experience reduced flooding along with the general public due to the reduced flooding of public infrastructure and the water quality and habitat improvements associated with the project.
