WHEREAS, the surveying profession requires special education, training, the knowledge of mathematics, the related physical and applied sciences, and requirements of law for evidence; and


WHEREAS, surveyors are uniquely qualified and licensed to determine and describe land and water boundaries for the management of natural resources and protection of private property rights; and
