TO ADOPT A REDISTRICTING PLAN FOR HUMBOLDT COUNTY

WHEREAS, *California Elections Code*, §§21500 et seq., require that, at least every ten (10) years, county legislative bodies shall meet and change the boundaries of county legislative districts or redistrict a county entirely if necessary, to apportion the county legislative body so that the members represent substantially equal populations; and

WHEREAS, consistent with the provisions of *California Elections Code*, §§21500 et seq., Humboldt County has prepared a redistricting plan which provides for a county legislative body composed of five members and which creates five districts as depicted on the official redistricting map for Humboldt County prepared pursuant to *California Elections Code*, §§21500 et seq.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. There is hereby adopted a redistricting plan for Humboldt County which provides for one supervisor in each of the five districts for a total county legislative body of five members. The districts for members of the county legislative body are depicted on the official redistricting map for Humboldt County prepared pursuant to *California Elections Code*, §§21500 et seq. A copy of the official redistricting map is attached as Exhibit A to this resolution and is incorporated herein by reference.
- 2. All members of the county legislative body shall be elected at large within the district wherein the candidate seeks election.
- 3. This plan shall take effect upon passage, the public welfare requiring it, provided that vacancies shall be filed in accordance with *California Elections Code*, §§21500 et seq.




