**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING ACCEPTANCE OF THE INDIGENT DEFENSE PROGRAM FUNDING FROM THE CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS IN THE AMOUNT OF THREE HUNDRED TWENTY-THREE THOUSAND FOUR HUNDRED DOLLARS (\$323,400)**

**WHEREAS**, the County of Humboldt (the “County”) desires to participate in the Indigent Defense Grant Program funded through the California Budget Act of 2020, (Senate Bill 74) and administered through the Board of State and Community Corrections (“BSCC”) Indigent Defense Grant Program; and

**WHEREAS**, BSCC has made available funding for the grant period of February 15, 2021 through June 30, 2023; and

**WHEREAS**, BSCC has awarded the Humboldt County Public Defender (“HCPD”) \$323,400 to supplement their Indigent Defense services;

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Public Defender is hereby authorized and directed to accept Indigent Defense Program grant funds in the amount of \$323,400.
2. The Public Defender, or a designee thereof, is hereby authorized and directed to act on behalf of the County in connection with the allocation of the Indigent Defense Program funding, and to enter into, execute and deliver any and all documents required, or deemed necessary or appropriate, to accept and secure such funding and the County’s obligations related thereto.
3. The County hereby certifies and represents that HCPD will utilize any and all Indigent Defense Program funding allocated thereto in accordance with any and all applicable local, state and federal terms, conditions, laws, regulations, standards and requirements.
