RESOLUTION NO. 18-130

RESOLUTION DESIGNATING EIGHT HUNDRED THIRTY-NINE THOUSAND DOLLARS (\$839,000.00) OF PREVIOUSLY ALLOCATED FUNDING TO BE USED FOR TRANSITION PLANNING, ADMINISTRATION AND OTHER ACTIVITIES RELATED TO THE HUMBOLDT COUNTY CORRECTIONS REENTRY RESOURCE CENTER PROJECT

WHEREAS, the County of Humboldt has been selected by the Board of State and Community Corrections (BSCC) to receive Twenty Million Dollars (\$20,000,000.00) to complete the Humboldt County Corrections Reentry Resource Center (CRRC) project; and

WHEREAS, as a condition of the award, BSCC requires that the County of Humboldt provide matching funds, via cash or in-kind contributions, up to ten percent (10%) of the award amount; and

WHEREAS, funding for the cash match has been identified from two sources: (1) Public Safety Realignment funds, which are derived from a combination of state sales tax, vehicle license fees and state general funds; and (2) the county's 2016 Finance Plan, which is composed of interim financing through an investment pool; and

WHEREAS, the amount from Public Safety Realignment funding mentioned above is in the amount of Five Hundred Thousand Dollars (\$500,000.00); and

WHEREAS, the amount of funding from the 2016 Finance Plan mentioned above is in the amount of Two Million Three Hundred Thousand Dollars (\$2,300,000.00). The Humboldt County Board of Supervisors on November 14, 2017 authorized this funding to be used towards the CRRC project, including the cash match and other activities associated with the project; and

WHEREAS, on December 18, 2018, the Humboldt County Board of Supervisors designated One Million Nine Hundred Sixty-One Thousand Dollars (\$1,961,000.00) of the previously allocated funding to be used as the cash match for the CRRC project; and

WHEREAS, the Board of Supervisors desires to formally designate the remaining Eight Hundred Thirty-Nine Thousand Dollars (\$839,000.00) in previously allocated funding to be used for transition planning, administration and other activities associated with the HCCRC project.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Humboldt County Board of Supervisors hereby designates Eight Hundred Thirty-Nine Thousand Dollars (\$839,000.00), derived from a combination of Five Hundred Thousand Dollars (\$500,000.00) in funding from Public Safety Realignment funding, and the remainder sourced from the 2016 Finance Plan, to be used for transition planning, administration and other activities associated with the Humboldt County Corrections Reentry Resource Center.
