

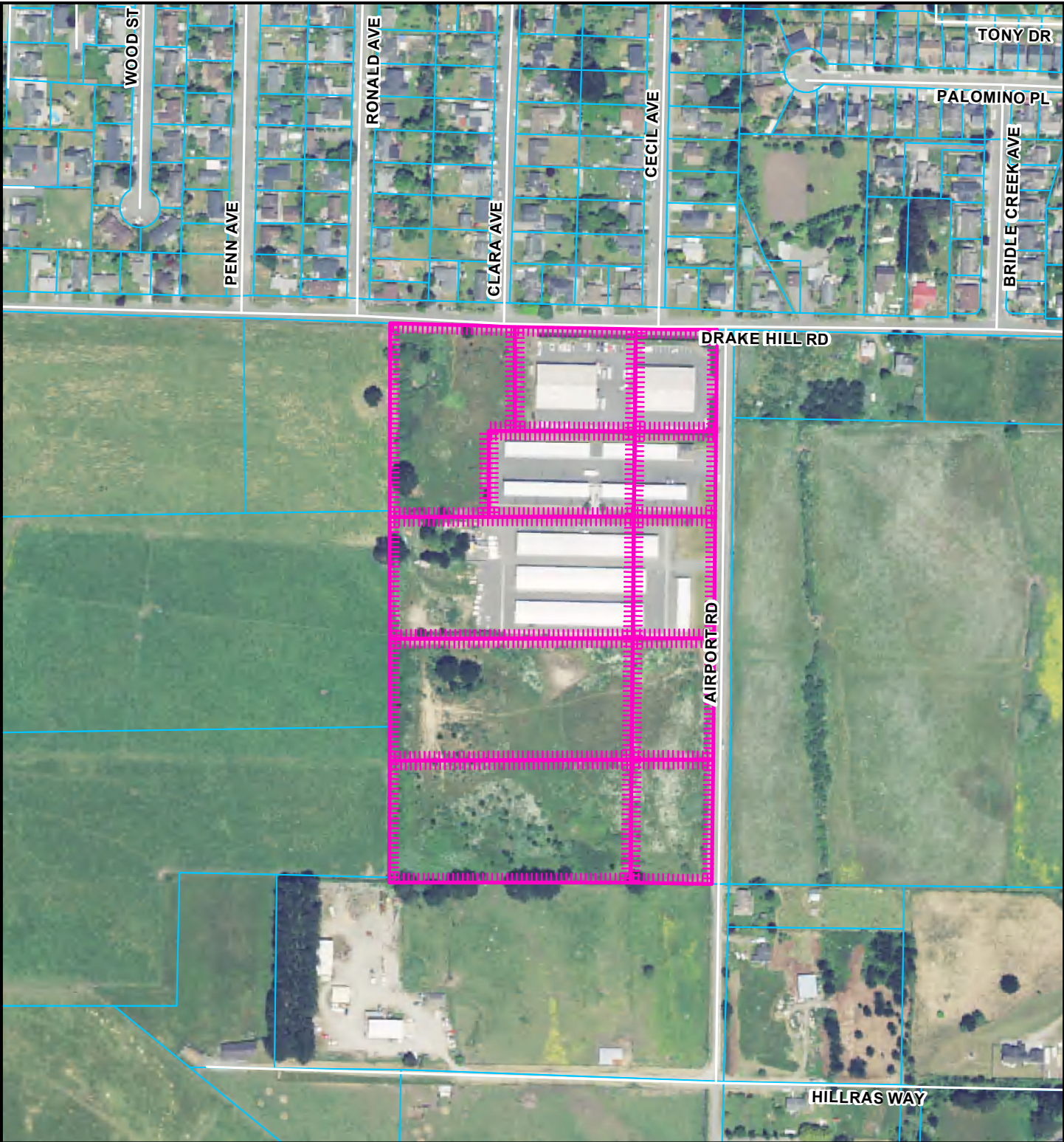
LOCATION MAP
