#### SOURCE OF FUNDING:

Economic Development Fund - State of California Employment Development Department funding

#### **DISCUSSION:**

The California Workforce Development Board in partnership with the State of California Employment Development Department has awarded one-time Workforce Innovation Opportunity Act (WIOA) funds for program year 2016-2017. These funds are provided to maximize the opportunity for a more timely and effective transition from the Workforce Investment Act of 1998 to WIOA. The award amounts are as follows:

## Regional Planning - \$26,803

Funds will be used for Workforce Development Board staff to work with regional partners in developing the Local and Regional Plan which is due to the state in March 2017.

# Regional Training Coordinator - \$43,385

Funds will be used for training and capacity building related to WIOA and the development of the customer center design at America's Job Center of California, locally known as The Job Market.

### Customer Center Design - \$55,000

Funds will be used to implement the elements of the customer center design plan at America's Job Center of California, locally known as The Job Market.

In addition to the one-time funding outlined above, the state awarded \$20,000 in Slingshot planning funds to the Humboldt County Workforce Development Board in 2015-2016. These funds were for planning strategies and implementing solutions to employment challenges which are distinct to this region of the state. These funds were not entirely expended in fiscal year 2015-2016, and the \$10,000 remaining needs to be carried forward into the 2016-2017 budget year.

#### FINANCIAL IMPACT:

Receipt of these funds will have no impact on the county's general fund. The requested supplemental budget will increase the Economic Development-Workforce Investment (1120-287) budget by \$135,188 for fiscal year 2016-2017.

This action supports the county's core role of "Supporting business, workforce development and creation of private sector jobs" in your Board's Strategic Framework.
