Hello All,

My name is Michael McGillicuddy, and I am the local representative for the Mandalorian Mercs Costume Club in Humboldt County. As well as Morale Officer for Teren Clan, which represents all Mandos from Sacramento to the Oregon border.

Personally, I moved to Humboldt County in April of 2023 from San Diego after receiving the opportunity to be a nurse at Saint Joe's in Eureka. When I arrived, I heard about the Forest Moon Festival and was eager to get involved since it seemed to be the only event supporting cosplayers/costumers in the area. Most of the time, members of the Lucasfilm associated costumes clubs are required to be at events officially sponsored by Lucasfilm. And the Humboldt County Film Commission was the only organization I had interacted with that had already worked directly with Lucasfilm to get the Forest Moon Festival sponsored as an official event. (Which is a big deal in the cosplay world!) It's been a pleasure working with your community to bring attention to artistic expression through Star Wars cosplay! As time has gone by in the past year, I've noticed a great motivation among the people of Humboldt County to express themselves creatively through cosplay. However, it seems that most people aren't really aware of a location or club to do these things, and find the ability to get into costuming an overwhelming obstacle on their own, and eventually give up on their dream to be a cosplayer. This is where events like the Forest Moon Festival come in!

On the surface, it seems like events like these are only for a niche group of people. However, these events are for people of all ages! Cosplay can help people learn costume design for costuming, set design to set a background for photo opportunities, make up for individuals playing certain characters, prosthetics for

people making alien characters, 3d printing for the armor pieces and small parts, electronics wiring for effects, and so much more. Being able to interact with the costume clubs provides a crowd sharing environment, making previously impossible tasks extremely doable. Power tools, 3d printers, and spray paint that would be otherwise unsafe or too expensive are available through the club functions and users are provided proper safety equipment and advice to use these tools to help make their imagination a reality. As their experience in cosplay grows they may choose to do other science fiction or fantasy cosplays, allowing for a more diverse cosplay community that attracts other clubs to the area. Most of these first interactions happen at tables provided at events like the Forest Moon Festival, and are the front lines in our efforts to grow the community.

If the Forest Moon Festival continues to be supported, you can expect the cosplay community in this area to grow, flourish, and have more cosplayers available in the area for other local events. Cosplay clubs like ours focus on events at local non-profit activities in non-commercial settings, such as community-level sporting events, charity walks, libraries, and K-12 schools! Less support would unfortunately mean less opportunities for locals to become cosplayers and less opportunities for official cosplayers to come to events in Humboldt. Costumers from Humboldt would have to travel to Redding, San Francisco, Sacramento, and other parts of California/USA for official events and would have to represent Humboldt elsewhere instead of having events in Humboldt County.

Thank you for your time. I hope we have the opportunity to do more events for the community in the future and have added the clan website for event requests to help facilitate this.

Dear Board of Supervisors,

I am writing in support of Option 2 in the staff proposals for the allocation of Measure J funds that will be under consideration tomorrow at your meeting.

I support Option 2 because of its sustained funding for the Film Commission and the recognition of the ability of film, television and media production to provide both immediate and sustained positive financial impacts to Humboldt County and the Redwood Region. The immediate impacts are the financial inflow observed during filming and the softer measures are the community pride and excitement from being part of "making movie magic." We witnessed these very impacts this spring during the Warner Brothers film.

Studies have shown that the more a community is highlighted in a particular film, the larger the increase in film tourism and rural areas have a great potential to benefit from a positive representation of a location with tourists seeking out movie locations to visit.(Kim, Park 2021) The sustained impact of film tourism has been demonstrated over and over with such films and TV series as Field of Dreams, Breaking Bad, Fargo and many more.

We have a unique opportunity to build upon a very successful brand, Star Wars, with the 1983 film, *Return of the Jedi*. It is a gift that keeps on giving – we benefited initially when the film was shot here, and now almost 41 years later, we are able to benefit from film tourism as fans want to travel to "The Forest Moon of Endore" which is ONLY located in the Redwood Region. This positive representation of the area's natural beauty and incredible forests has captivated audiences turned to fans since the beginning.

The challenges of tracking the financial impacts of film tourism are widely recognized although a few areas have been able to generate data on the impact using "heads in beds" and "gate admission". For example, the movie, *Close Encounters of the Third Kind*, was able to identify a 75% increase in tourism within a year of release and a sustained increase of 20% as measured by admission tickets to the Devils Tower rock formation. Here in Humboldt County, the Forest Moon Festival is scheduled for a weekend identified by the Humboldt Lodging Alliance as a historically low volume weekend. Although we don't have hard numbers to reflect the increase, we have many, many stories of families who traveled to participate in the Forest Moon Festival. We anticipate the same positive impact to local hotels and lodging accommodations this year.

Because the success of film tourism depends on the community hosts, the Film Commission has been working within the community to create a film friendly environment for productions and tourists. Newspaper articles, television appearances, and talks at professional groups, service clubs and schools have all created a film friendly community. This positive, receptive attitude is noticed and valued by productions and tourists alike. In 2012, the Deputy Film Commissioner updated a very old map of movie locations in Humboldt County. This was published as a paper map called Map of the Movies. The map was distributed to local hotels, motels, and tourist locations. The Film Commission updated the map again to be available as an experience app and has retained the paper Map of the Movies. The experience app now features the Forest Moon Festival as well as all the movie locations. The Forest Moon Festival is the hook that brings people into the app, and then to visit our area.

The proposed Option 2 for the Measure J funds identify Tourism, Film and the Arts as the focus with the specific areas of focus for the Film Commission as the Forest Moon Festival and the Sound Stage. The Forest Moon Festival is, in essence, the culmination of years of film tourism efforts and a recognition of our unique and powerful resource in 'the Forest Moon of Endore' location.

The Sound Stage exploration can be framed as an exploration of the viability of building a new industry in the county. It would serve as a magnet to attract productions and retain a much greater share of the production activity within the county. The ability of a sound stage to transform the economic profile of an entire region is well known and visible as in Atlanta, Georgia.

Making the best allocation of the Measure J funds is a challenge given all the competing priorities. The Film Commission, with the Forest Moon Festival and the sound stage exploration, provides a means to increase revenue coming into the county, potentially create a new industry, build upon the positive representation the county has had with productions that have worked here, and provide lasting memories for locals and visitors.
