Resolution Authorizing a Determination of Public Convenience Related to the Issuance of a Type 20 Alcoholic Beverage License

RECOMMENDATION(S):

That the Board of Supervisors:

1. Adopt the attached resolution authorizing the determination of public convenience related to the issuance of a Type 20 Alcoholic Beverage License to the owner/operator of Camp Trinidad LLC, located at 3443 Patrick's Point Dr. in Trinidad, CA.

DISCUSSION:

Camp Trinidad LLC, located at 3443 Patrick's Point Dr. in Trinidad, CA, has submitted an application to the Department of Alcoholic Beverage Control for a Type 20 Alcoholic Beverage License.

The Type 20 Alcoholic Beverage License is specifically designed for businesses that operate as a convenience store, grocery store or small market. This license permits the sale of beer and wine for consumption off-premises where they are purchased. It does not authorize the sale of distilled spirits or hard liquor.

Camp Trinidad LLC received notification from the Department of Alcoholic Beverage Control that they needed a resolution from the County of Humboldt's Board of Supervisors to make a determination of "public convenience." Upon adoption of the resolution, Camp Trinidad LLC may proceed with the approval process.

Supervisor Madrone has conducted community outreach within the area of this business and recommends approval of the resolution.
