**RESOLUTION NO. 22-90**

**RESOLUTION FOR EXCEPTION TO THE 180-DAY WAIT PERIOD GOVERNMENT CODE SECTIONS 7522.56 & 21224**

**WHEREAS**, in compliance with Government Code section 7522.56, the Humboldt County Board of Supervisors must provide this certified resolution to the California Public Employees Retirement System (CalPERS) when hiring a retiree before 180 days has passed since his/her retirement date; and

**WHEREAS**, Ms. Cathy Rigby (Employee ID#R3702) will retire from the Humboldt County Department of Health & Human Services as a Program Manager – Behavioral Health, effective July 15, 2022; and

**WHEREAS**, section 7522.56 requires that Ms. Rigby's post-retirement employment commence no earlier than 180 days after the retirement day, or before January 15, 2023, without this certified resolution; and

**WHEREAS**, section 7522.56 provides that this exception to the 180 day wait period shall not apply if the retiree accepts any retirement related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors, the Humboldt County Department of Health and Human Services, and Ms. Rigby certify that Ms. Rigby has not and will not receive a Golden Handshake or any other retirement related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors hereby appoints Ms. Rigby as an extra help retired annuitant to perform the duties of a Program Manager – Behavioral Health for the Department of Health and Human Services under Government Code Section 21224, effective, July 25, 2022; and

**WHEREAS**, no matters, issues, terms, or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

**WHEREAS**, the employment shall be limited to 960 hours per fiscal year; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the maximum base salary for this position is \$9,114.22 per month and the hourly equivalent is \$52.58 and the minimum base salary for this position is \$7,102.58 and the hourly equivalent is \$40.98; and

**WHEREAS**, the hourly rate paid to Ms. Rigby will be \$52.58; and



Ms. Rigby has unique knowledge, skills and relationships required to provide program compliance for MHSA and ESM mandates. This appointment will allow a period of transitional support for continued operation of critical programs and compliance within the Humboldt County Department of Health and Human Services, Behavioral Health Branch.
