Based upon the ROTR 2024 report, it appears MCC, County of Humboldt and partner agencies are taking prudent care to manage traffic and parking with this annual event.

Highlights from the report:

- 1,747 car passes were sold, including RV and camping passes.
- 470 vehicles remained on-site.
- Traffic and parking staff screened vehicles for leaking oil, oil absorbing pads were provided to suspect vehicles, and post-event staff found no oil leaks.
- 1,200-1,500 one-way free shuttle rides provided each day from off-site parking locations.
- For 2025, financial incentives will be provided encourage shuttle ridership.

If California Highway Patrol or Humboldt County Sheriff report operational issues with traffic, then of course those should be evaluated and addressed.

However, this report indicates a thorough approach to traffic and parking management with ROTR and the County Line Ranch.

PROJECT DESCRIPTION:

Review of the Annual Report for the approved Conditional Use Permit authorizing events held by the Mateel Community Center (MCC) in 2023 at the County Line Ranch (formerly Dimmick) in the Cooks Valley area. The permit allows two music festivals to be held annually. Both events feature live music, camping and various vendors, including cannabisrelated concessions and consumption within discrete areas on the properties. One event is the Summer Arts and Music Festival which occurs over two days and is ordinarily held during the third weekend in June. The second event is Reggae on the River, which ordinarily occurs over three days during the first weekend in August. The Summer Arts and Music Festival was not held at the County Line Ranch in 2024 but instead occurred in Redway on June 8th and 9th at the Mateel Community Center. The Reggae on the River event was held on August 2, 3 and 4 of 2024. The Use Permit was approved by the Planning Commission in 2023 and requires the Mateel Community Center to submit a monitoring report to the Planning Commission for review on an annual basis. During review, the Commission is authorized to amend conditions or operational requirements if needed to better mitigate potential impacts or control public nuisance -the Commission may also adjust attendance levels under the permit based on annual performance.
