

This permit is not transferable without prior notification and approval from the City. The original copy of this permit shall be maintained at the above listed address. Additional copies of this permit may be obtained by contacting the Pretreatment office.

The permittee shall apply for a new permit at least 45 days prior to the expiration date stated below if the activities regulated by this permit will continue beyond the expiration date.

This permit shall become effective on **April 1st, 2024** and shall expire on **April 1st, 2026**
