RESOLUTION NO. 18-53

RESOLUTION AUTHORIZING TEMPORARY CLOSURE OF THE SOUTHBOUND LANE OF STATE ROAD 255, THE RIGHT LANE OF SOUTHBOUND US 101 (SAFETY CORRIDOR), AND CONTROLLED TRAFFIC ON VARIOUS COUNTY ROADS FOR THE HUMBOLDT BAY MARATHON, HALF MARATHON, 5K, AND MARINA MILE RACES ON SUNDAY, AUGUST 12, 2018

WHEREAS, Humboldt Bay Marathon is planning the 4th Annual Humboldt Bay Marathon, Half Marathon, 5K, and Marina Mile races on Sunday, August 12, 2018 from 7:00 A.M. to 2 P.M. and is requesting that the following specific section of State Route 255, the right lane and shoulder of southbound US 101 in the Safety Corridor, and additional county roads be closed temporarily with controlled traffic:

1. The southbound lane and shoulder of State Route 255 from Jackson Ranch Road to 3rd Street in Eureka will be closed to all traffic but official race and emergency vehicles. Local traffic in Samoa and Manila will be allowed to cross the race route and use the northbound lane of State Route 255
2. The right lane and shoulder of southbound US 101 (Safety Corridor) will be closed from Bayside Cutoff to Y Street in Eureka (until 9 AM only). The left lane will remain open for southbound traffic
3. The right lane and shoulder of northbound New Navy Base Road will be closed from Cookhouse Road to State Route 255
4. Jackson Ranch Road, Foster Road, Seidel Road, Lanphere Road, Mad River Road, Miller Lane, Parton Lane, Alice Avenue, Ernest Way, and Upper Bay Road will be closed to thru traffic
5. The southbound lane of Vance Avenue from State Route 255 to Cookhouse Road and the westbound lane of Cookhouse road will be closed

WHEREAS, the California Department of Transportation requires an adopted resolution from the Humboldt County Board of Supervisors authorizing the above closures.

NOW, THEREFORE BE IT RESOLVED, that the Humboldt County Board of Supervisors authorizes the temporary closure of the southbound lane of State Route 255, the right lane and shoulder of southbound US 101, and other county roads as listed above on August 12, 2018 between the hours of 7:00 a.m. and 2:00 p.m. in order to allow Humboldt Bay Marathon to conduct the Annual Humboldt Bay Marathon; and


