
#### **VICINITY MAP** NOT TO SCALE

#### **PROJECT DESCRIPTION:**

MYERS AND AQUARIAN, LLC IS PROPOSING TO PERMIT EXISTING CANNABIS CULTIVATION ACTIVITIES IN ACCORDANCE WITH THE COUNTY OF HUMBOLDT (COUNTY) COMMERCIAL MARIJUANA LAND USE ORDINANCE (CMLUO). THE EXISTING OPERATION INCLUDES APPROXIMATELY 24,000 SQUARE FEET (SF) OF OUTDOOR CULTIVATION AREA. THE PROJECT PROPOSAL INCLUDES THE DEVELOPMENT OF FACILITIES APPURTENANT TO THE CULTIVATION. 








