**PRE-ADOPTION SUMMARY OF PROPOSED URGENCY ORDINANCE ESTABLISHING A TEMPORARY MORATORIUM ON THE CULTIVATION OF INDUSTRIAL HEMP BY "ESTABLISHED AGRICULTURAL RESEARCH INSTITUTIONS" OR OTHERS WITHIN THE UNINCORPORATED AREAS OF THE COUNTY, WHICH SHALL TAKE IMMEDIATE EFFECT**  
On Tuesday, April 2, 2019, during its regularly scheduled Board meeting, the Humboldt County Board of Supervisors will consider the adoption of a proposed urgency ordinance, to take immediate effect, to establish a temporary moratorium on the cultivation of industrial hemp as otherwise provided by California Food and Agriculture Code sections 81000 - 81011 by "established agricultural research institutions" or others within the unincorporated area of the County of Humboldt. The moratorium would initially be in effect for 45 days after enactment, and may be extended by further action by the Board of Supervisors within that time period for a total of up to two years. A four-fifths vote is required for adoption.
