DESCRIPTION OF INQUIRIES RECEIVED FROM FEDERAL IMMIGRATION:

The Probation Department did not receive any inquiries from the federal agency charged with enforcement of federal immigration law for the reporting period of January 1, 2022 to June 30, 2022. As this semiannual report is required by statute to be presented to the Board Of Supervisors by January 1st and July 1st, any inquiries received in the last weeks of June will reported to the Board either through amendment of the Agenda Item or submission of a subsequent Agenda Item.

In addition, the Probation Department did not receive any inquiries from the federal agency charged with enforcement of federal immigration law for the reporting period of December 15, 2021, and January 1, 2022, the time between the last report to the Board and the end of the calendar year.
