A RESOLUTION APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2024 FUNDING YEAR OF THE STATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

WHEREAS, the California Department of Housing and Community Development issued a Notice of Funding Availability for 2024 Community Development Block Grant program; and

WHEREAS, on March 31, 2024, staff with Humboldt County Planning and Building Department held a properly noticed public meeting to describe the funding available and eligible uses and solicit input from the community regarding community needs; and

WHEREAS, input from the public meeting was used to inform a proposal to assist low to moderate income persons to utilize the CDBG 2024 funding; and

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND RESOLVED by the Board of Supervisors of the County of Humboldt as follows:

SECTION 1

The Board of Supervisors has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$3.3 million for the following CDBG activities, pursuant to the 2024 CDBG NOFAs:

SECTION 2

The Board of Supervisors hereby approves the use of Program Income in an amount not to exceed \$3.3 million for the CDBG activities described in Section 1.

If an application is approved, the Director of Planning and Building is authorized to enter into, execute and deliver the grant agreement (*i.e.*, Standard Agreement) and any and all subsequent amendments thereto with the State of California for the purposes of the grant.

SECTION 6

If an application is approved, the Director of Planning & Building is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
