NOTICE IS HEREBY GIVEN, pursuant to Government Code section 25350, that on June 23, 2020, at 1:30 p.m., or as soon thereafter as the matter can be heard, the Humboldt County Board of Supervisors will hold a public hearing to receive public comment and testimony regarding the proposal for Humboldt County to acquire real property to expand the McKay Community Forest, as described below. Further information is available here: https://humboldtgov.org/1808/McKay-Community-Forest.

The Humboldt County Board of Supervisors Intends to consider approving the acquisition of approximately 197 acres of timberlands for the expansion of the McKay Community Forest located southeast of Eureka. The parcel under consideration (Assessor Parcel No. 303-012-029) is situated east of Ridgewood Heights. If acquired, the parcel would be managed for multiple objectives including public access and recreation, sustainable timber management, and watershed and resource protection. The primary access point to the parcel for public use would be the designated parking area on Northridge Road. Opportunities for access points within Ridgewood Heights are not being considered at this time. Any proposed access point within Ridgewood Heights would be subject to a future public review process. The parcel would be acquired from Green Diamond Resources Company, a willing seller, with state and private funds for the sum of \$1,355,000. No County funds would be used for the purchase

Any and all interested parties are invited to participate in the hearing and provide public comment. The hearing will be held on Tuesday, June 23, 2020, at 1:30 p.m. or as soon thereafter as the matter can be heard. In accordance with Executive Order N-29-20, this meeting will be held virtually.
