**RESOLUTION NO. 22-193**

**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS  
ESTABLISHING THE TARGET FUNDING LEVEL FOR THE SELF-  
INSURANCE SUB FUNDS**

**WHEREAS**, Part 200.447 of the Code of Federal Regulations, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, provides that contributions to self-insurance reserves must be based on sound actuarial principles using historical experience and reasonable assumptions; and

**WHEREAS**, Part 200.447 requires that reserve levels be analyzed and updated at least biennially for each major risk being insured and reserve levels in excess of the amounts based on the above must be identified and justified in the cost allocation plan or indirect cost rate proposal; and


**WHEREAS**, California Government Code Section 29000, the County Budget Act, provides that reserves will be established by the Board of Supervisors; and

**WHEREAS**, Bickmore Actuarial completed an Actuarial Review of the Self-Insured Liability Program for the County of Humboldt on October 25, 2019 for Fiscal Years 2019-20 and 2020-21 recommending that program assets are maintained at the 80% confidence level; and

**WHEREAS**, the County of Humboldt maintains eight self-insurance sub funds: General Liability, Dental, County Insurance, Workers' Compensation, Medical, Unemployment, Purchase Insurance Premiums, and Employee Benefits.

**NOW, THEREFORE, BE IT RESOLVED** that the County of Humboldt selects to maintain the self-insurance sub funds target funding levels at the 80% confidence level to be evaluated based on sound actuarial principles biennially in accordance with Part 200.447 of the Code of Federal Regulations, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards.
