The following information should be added to the Cultivation and Operations Plan for Kurnishon LLC, APPS #12030, APN: 208-221-006.

Clarification on Water Source

The Applicant uses a permitted ground water well as their source of irrigation for cannabis. A copy of the well completion report will be provided to your office.

Generator Usage

The Applicant anticipates running their generator for domestic purposes approximately 12 hours a day (year-round). During the cultivation season (March-November) the Applicant will run their generators for approximately 3-4 hours a day.

Processing Practices

Until a proper structure can be permitted with the Humboldt County Planning and Building Department, the Applicant will seek out a licensed third-party processor.

Employees Safety Practices

All those working on the property will be instructed in safe and proper techniques for performing any duties pretraining to cultivation. This includes the utilization of personal protective equipment and proper use of tools and necessary instruments required for the performance of one's duties. Personal protective equipment shall be provided for all employees and/or independent contractors via the proponent as well as having ample personal protective equipment in stock and onsite. Clean and safe drinking water will be in the form of filtered spring water. For the safety of the public and employees working while intoxicated will not be tolerated. All Employee and/or independent contractors shall be made aware of the following.

- I. Location of fire extinguishers and the "P.A.S.S" technique.
- II. List of operations manager contacts;
- III. List of emergency control contacts;
- IV. List of poison control contacts;
- V. Location of first aid kit;

- VI. Location of Restroom and hand washing stations;
- VII. Location of clean drinking water and;
- VIII. Location of Personal protective equipment.

All work surfaces and equipment are maintained in a clean, sanitary condition. Protocols to prevent the spread of mold are strictly followed.

Sanitation

Until a septic can permitted with the department of environmental, the Applicant will provide those working on the property with portable toilets.

Road Impact

To minimize the impact of increased road usage the Applicant will rock the road, this will ensure the debris pickup from increased road usage will be minimized.

Onsite Housing

There will be no onsite housing for employees.

Site Management Plan/Remediation Plan

Green Road Consulting is to complete both items mentioned above. The Applicant has contracted Green Road Consulting to enroll them in the State Water Board. Enrollment in the State Waterboard also includes a site management plan. The site management plan will address the subject of the remediation. The site management plan will include methods of restoration and will target to abate existing environmental harm at the former cultivation site. Once the Site management is complete a copy will be provided to the planning and building department.
