RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING ACCEPTANCE OF GRANT FUNDING MADE AVAILABLE BY THE CALIFORNIA DEPARTMENT OF INSURANCE THROUGH THE AUTOMOBILE INSURANCE FRAUD PROGRAM THROUGH CALIFORNIA INSURANCE CODE SECTION 1872.8, CALIFORNIA CODE OF REGULATIONS, TITLE 10, SECTION 2698.60 ET. SEG. AND ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF INSURANCE

WHEREAS, the Humboldt County District Attorney's Office has partnered with both the Del Norte and Trinity County District Attorney's Offices for the purpose of developing and operating a regional Insurance Fraud Unit; and

WHEREAS, the regional Insurance Fraud Unit is responsible for investigating and prosecuting automobile fraud, and providing community outreach regarding identification and reporting of insurance fraud in all three regional areas; and

WHEREAS, on July 7, 2020, the County of Humboldt ("County"), by and through the Humboldt County District Attorney's Office, submitted an application for grant funding made available by the California Department of Insurance through the Automobile Insurance Fraud Program in order to continue operating the regional Insurance Fraud Unit during fiscal year 2020-2021; and

WHEREAS, on September 16, 2020, the California Department of Insurance awarded the Humboldt County District Attorney's Office grant funding through the Automobile Insurance Fraud Program in the amount of Seventy-One Thousand Seven Hundred Sixty-One Dollars (\$71,761.00) to allow for the continued operation of the regional Insurance Fraud Unit during fiscal year 2020-2021; and

WHEREAS, the County of Humboldt ("County"), by and through the Humboldt County District Attorney's Office, will reapply for grant funding made available by the California Department of Insurance through the Automobile Insurance Fraud Program in order to continue operating the regional Insurance Fraud Unit during fiscal year 2021-2022.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

- 1. The County's submission of an application for grant funding made available by the California Department of Insurance through the Automobile Insurance Fraud Program is hereby ratified.
- 2. The Humboldt County District Attorney, or a designee thereof, is hereby authorized to enter into, execute and deliver a State of California Standard Agreement for the amount of Seventy-One Thousand Seven Hundred Sixty-One Dollars (\$71,761.00), and any future amendments thereto, along with any and all other documents required or deemed necessary or appropriate to evidence and secure the grant funding awarded by the California Department of Insurance through the Automobile Insurance Fraud Program.

- 3. The County shall not use any of the grant funds received through the Automobile Insurance Fraud Program to supplant expenditures controlled thereby.
- 4. It is agreed that any liability arising out of the performance of the Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the Humboldt County District Attorney's Office and the County of Humboldt. The State of California and the California Department of Insurance disclaim responsibility for any such liability.
