

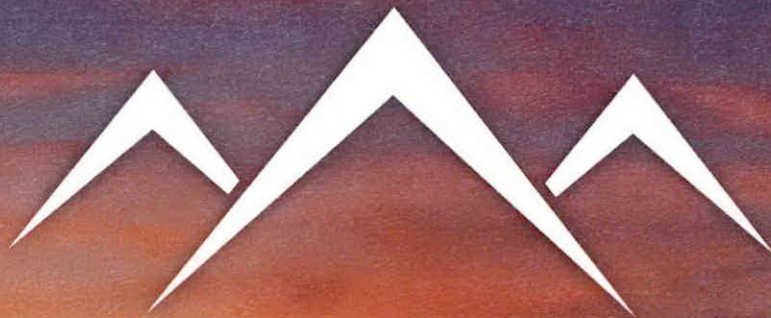

GOOD MORNING. I DAVID GOMEZ WAS ARRESTED BY Humboldt County Sheriff Deputy Tomlin, REPORT # 201502492 ON MAY 29 2015. DEPUTY TOMLIN DID NOT FOLLOW PROPER " PRACTICES AND PROTOCOLS THAT LAW REQUIRES " TO FOLLOW PEACE OFFICER GUIDELINES, DEPUTY TOMLIN DID NOT GIVE ADEQUATE INTERPRETATION OF HIS PERCEPTION OF THE CITIZENS COMPLAINT ALLEGING CRIMINAL CONDUCT OF EITHER A FELONY OR MISDEMEANOR, DEPUTY TOMLIN FAILED TO INVESTIGATE AND DISCLOSE SUFFICIENT EVIDENCE TO PROVE THE TRUTH OF ALLEGATION IN THE COMPLAINT BY PREPONDERANCE OF EVIDENCE, DEPUTY TOMLIN'S CONDUCT AS A PEACE OFFICER TO NOT DISCLOSE ADEQUATE EVIDENCE SUCH AS PHOTOS, DIAGRAMS DISCOVERED TO SUPPORT THE ALLEGATION IS A VIOLATION OF MY CIVIL RIGHTS AS A CITIZEN, TO REMOVE DAVID GOMEZ FROM HIS PROPERTY WITHOUT SUSTAINED EVIDENCE, OR SOME OTHER CORROBORATING EVIDENCE BEYOND REASONABLE DOUBT, THAT THE CITIZEN COMPLAINT IS THE TRUTH, UNDER IDENTITY PROFILING. I DAVID GOMEZ WOULD LIKE A INVESTIGATION INTO THIS COMPLAINT ON MAY 29, 2015 THAT LEAD TO THE ARREST OF DAVID GOMEZ. THE CONDUCT OF DEPUTY TOMLIN WAS BIASED AND DETRIMENTAL TO MY MENTAL AND PHYSICAL HEALTH, WITH DOCTOR APPOINTMENTS BECAUSE OF ANXIETY ATTACKS, LOSS OF TIME AND SAVINGS, EVERYTHING FROM EXTRA MILES ON VEHICLES, YEARS IN COURT, ALSO FAILURE TO PUT ON RECORD THAT THE CITIZENS COMPLAINT WAS UNFOUNDED.
