#### SONOMA COUNTY LAW ENFORCEMENT/COURT AND ELECTRONIC SECURITY ACCESS EXPERTS.

In particular, FSS' Regional Branch Manager, Michael Ferguson as a law enforcement Lieutenant in charge of the Court Security Bureau (1996). Operations Manager, Brendon Culbertson has significant experience in high profile X-Ray and electronic screening processes working with and trained by Los Angeles Police Department as a security lead at the annual Academy Awards events in Los Angeles. This professional team will train and daily oversee every location in the Court system designated.

**Lt. Mike Ferguson** worked in concert with the Sonoma County Court Administrator in developing the Sonoma County Courthouse security plan. Lt. Ferguson was responsible for researching existing courthouse security policies, and plans. He wrote the initial implementation plan, and formed an advisory board for developing best practices for moving forward with a courthouse security program. This was at the request of the presiding Superior Court Judge.

Lt. Ferguson researched other courthouse security programs throughout the U.S.A., He sought out, and identified the best vendors for equipment to be used at the screening stations. He also assisted the Court Administrator in writing the proposal for security staffing. In addition he personally provided an introduction of the program, and training to all courthouse employees, and other professionals that frequently use the Courthouse, such as private attorneys.

Mr. Ferguson has a hands on understanding of the Sonoma County Courthouse, and the security needs that are fundamentally the same as when he developed the protocols.Mr. Ferguson has 44 years of combined law enforcement and security management experience.He would be the executive manager of this contract.

There are six (6) frequencies, UHF, private channel two-way radio system with repeaters on all the significant California local mountain tops providing professional radio communication in our entire service area and beyond. We can and will reprogram our radio frequencies to conform to law enforcement and media channels where appropriate.



## STAFFING PLANS

Staffing for the project will begin with the North Bay workgroup under the direction of Branch Manager Michael Ferguson and Operations Manager Brendon Culbertson.

Members of the executive team will be involved in the strategy and will visit venues during the service period.

#### **Continuity Assurance & Reconciliation**

All officers will be provided a FSS owned radio (which can be programmed to integrate to event channels where applicable) for immediate communication. GPS and dispatch check in requirements will verify that we have an officer onsite as scheduled.

FSS should not consistently fail to meet staffing requirements as committed. However, where failures occur, FSS would compel interactive participation with executive management to ensure any failures are immediately corrected.

Because management staff is required to step in where officers are unable to respond, the Court would not experience a "dark" post.

FSS' FirstTrac guard tour will help let us know if officers are not reporting in on time. No contact in by FirstTrac will result in a call to supervision by our dispatch staff.



## **SUBJECT MATTER EXPERTISE**

FSS has the experience to fully understand the requirements under this RFP, and the expertise to meet or exceed all requirements. In particular, FSS' Regional Branch Manager and Subject Matter Expert, Michael Ferguson was the law enforcement Lieutenant in charge of the Court Security Bureau (1996). Operations Manager, Brendon Culbertson has significant experience in high profile X-Ray and electronic screening processes working with and trained by Los Angeles Police Department as a security lead at the annual Academy Awards events in Los Angeles.

**Lt. Mike Ferguson** worked in concert with the Sonoma County Court Administrator in developing the Sonoma County Courthouse security plan. Lt. Ferguson was responsible for researching existing courthouse security policies, and plans. He wrote the initial implementation plan, and formed an advisory board for developing best practices for moving forward with a courthouse security program. This was at the request of the presiding Superior Court Judge.

Lt. Ferguson researched other courthouse security programs throughout the U.S.A., He sought out, and identified the best vendors for equipment to be used at the screening stations. He also assisted the Court Administrator in writing the proposal for security staffing. In addition he personally provided an introduction of the program, and training to all courthouse employees, and other professionals that frequently use the Courthouse, such as private attorneys.

Mr. Ferguson has a hands on understanding of the Sonoma County Courthouse, and the security needs that are fundamentally the same as when he developed the protocols.Mr. Ferguson has 44 years of combined law enforcement and security management experience.He would be the executive manager of this contract.

**Lt. Brendon Culbertson** is a Certified Systems Administrator for CCURE 800 and 9000 by Software House, Tyco International.

Lt. Culbertson is experienced in Metal Detection as well as XRAY Screening gained through starting as a screener for TelePlan International, an HP Company, screening all employees for microchips and company assets hidden on their person or in their bags; and later as a Ramp Security Agent /Coordinator/Loadmaster for Airborne Express/DHL, screening flight crews and passengers prior to boarding along with a search and detection of all aircraft for unknown items or threats.

Finally rounding out as the Event Security Manager for AMPAS, Academy of Motion Picture Arts and Sciences also known as the Oscars. Coordinating the setup, deployment, and training of 16 kiosk check points manned by 150 LAPD and 500 Security Officers at the venue, Dolby Theatre, utilizing both hand and walk through metal detection devices as well as proprietary XRay screening.

Lt. Culbertson was trained by the task force of FBI, DHS, LAPD, and US Marines teams on the modern screening techniques as well as terrorist counter procedures encompassing such a large venue that is also open to the public.



#### STRINGENT NEW-HIRE REQUIREMENTS

We have done thorough review of the RFP and will comport with hiring requirements contained therein. In addition to meeting all requirements outlined, FSS candidates must also exhibit the following skills.

- Skill in verbally communicating effectively and professionally
- Skill in generating trust and respect from clients, co-workers and the public
- Skill in observing and noticing unusual circumstances or items; able to interpret and respond to body language cues
- Skill in observing people to detect suspicious actions and deter undesirable behaviors
- Skill in verbally diffusing situations and effectively resolving problems and issues
- High prioritization of safety and security of people and property
- Demonstrate public relations skills: able to interact professionally

#### EXPERIENCE CRITERIA FOR OFFICERS ASSIGNED TO DUTY

FSS's Officers assigned to duty typically have a minimum of one year of professional experience in a recognized security organization, military, law enforcement or proprietary security assignment. Officers will be screened (and specially trained) for exceptional Customer Service skill as security staff will work directly with *the client's* employees/contractors, and local law enforcement agencies.

#### CONTINGENCY STAFFING/OFF-SITE TRAINED BACKFILLS / RESERVE FORCE

Additional off-site officers will be cross-trained to meet the requirements of the sites and assure FSS' ability to supply additional armed and unarmed officers within 2-4 hours from time notified, and be able to respond if/when work schedules expand. To ensure coverage of some assignments/posts that may require specially trained and more qualified security officers and/or supervisors(s), we routinely build a total trained force of approximately 120-125% of requirements (and obtain client approval as necessary of all 125%); this is our normal practice, to give staffing depth to our smaller sites with limited backfill and also to enhance our ability to expand coverage when necessary. We use a carefully measured blend of primarily full-time plus part time staff (commonly off-duty local law enforcement officers who frequently seek out positions due to their respect for our quality and methods).

#### **BSIS CRIMINAL BACKGROUND CHECK**

Included in the state registration process are a Live Scan electronic fingerprint and criminal background check through the Department of Justice ("DOJ") and the Federal Bureau of Investigation ("FBI"). The DOJ and FBI deny approval where particular criminal history is found (e.g. convictions for crimes of moral turpitude, and in particular, substance abuse, violence or sex-related crimes). The DOJ does not provide specifics for denial – it simply denies the application and causes the BSIS to send a notice of denial to both the prospective employer and the applicant. As part of its ongoing update, where BSIS receives notice of subsequent disqualifying violation(s), it sends to Patrol company operators notices of revocation or similar notices. Once received, it is the patrol operator's duty to remove the disqualified guard from Post.

FSS follows this protocol to the letter.



#### **EMPLOYMENT REFERENCE CHECK**

FSS requires all applicants to provide verifiable employment history and releases for reference checks. FSS conducts telephonic and/or mail inquiries to listed references and considers the results of these reference responses in its employment decision.

#### SUPPLEMENTAL COMMERCIAL BACKGROUND CHECK

FSS requires all personnel to submit to a commercial background check. This check scans sexoffender registries, tracks address history by state (California county), and where indicated, 14 County Criminal records check and where necessary, full United States criminal histories.

This check also provides the company with other behavior history which helps it to evaluate the general responsibility and honesty of the applicant. For example, results can contradict responses provided by the applicant during the interview process, creating an opportunity for further discussion. Applicants provide voluntary releases for this background check, and any adverse employment decision based solely on the results is provided to the applicant consistent with California law.

FSS also submits identities through Global Watch List/Office of Foreign Asset Control (OFAC)/Terrorist Watch Lists (Includes among many: Bank of England Sanctions, Commodity Futures Trading Commission List of Regulatory and Self-Regulatory Authorities, Defense Trade Controls (DTC) Debarred Parties, FBI's Most Wanted, Financial Crimes Enforcement Network Special Alert List, Foreign Agent Registrations, International Police Most Wanted and Red Alerts, Office of Foreign Asset Control (OFAC), OFAC - Palestinian Legislative Council OFAC - Enhanced Sanctioned Countries, Office of Controller of Currency.

This check also covers Public Records/Watch\Risk Lists for the entire United States and territories.

#### CONFIDENTIALITY

All employees, as part of the existing new hire process, sign confidentiality agreements drafted specifically to protect the business confidential/trade secret information of FSS and of its clients.

During orientation, we take time to discuss what confidential | trade secret | proprietary and private information is so that each officer can identify it and maintain protocol as required.

#### **DRUG FREE WORKPLACE POLICY**

FSS has continuously and strenuously maintained an Alcohol and Drug Free Workplace policy the entire span of its business history (since 1966). Its substance free policy is enforced with ZERO tolerance and is a condition of employment.

FSS uses a combination of saliva quick tests and full SAMHSA complaint laboratory alcohol and drug



screens to ensure that every employee is drug free at hire. FSS's policy (written and approved by outside legal counsel) provides for post offer drugs screens for all safety sensitive positions (all security positions) including post hire reasonable suspicion and post-accident screening.

FSS drug and alcohol program includes a US Department of Transportation Federal Transit Administration compliant policy, training program for employees and supervisors and testing for all



armed security guards assigned pursuant to federal regulations 49 CFR parts 40 & 655. FSS will also cooperate with all reporting requirements including quarterly program reports, the annual federal drug and alcohol MIS report, periodic site visits and processing of annual re-certification forms.

## **PAY STRUCTURE**

The largest proportion of the bill rate to the client is the security officer's wages and benefits. That is why FSS stresses the officer wage to the client during negotiations. Quality officers deserve the highest wages and benefits the venue can bear competitively. The result is consistently better under this schema.

FSS references the Bureau of Labor Statistics employment wage statistics, market standards; collective bargaining wage and benefit benchmarks; and any living or minimum wage requirements when considering its wage to the officer. Wages and benefits include all statutorily required leave benefits.

FSS pays its employees through its in-house accounting/payroll department. Unlike national companies that process out of state, FSS workers can simply walk into the local office and pick up their check. FSS offers direct deposit, PayCard and live check options. FSS will mail the employees' check with written authorization.

Where any discrepancy is found (and there should not be as the officers are required to complete their own timesheet and report whether meal and rest breaks are taken) a correction check is immediately issued from our San Jose based payroll department.
