The Humboldt County Civil Grand Jury investigates and reports on the operations, accounts and records of the officers, departments or functions of the County of Humboldt and other local government agencies. The county thanks the Grand Jury for its hard work and efforts its members have put forth in their 2023-24 Grand Jury reports.
