PUBLIC NOTICE

On November 14, 2017, during its regularly scheduled Board meeting, the Humboldt County Board of Supervisors adopted an urgency ordinance, Ordinance No. 2586, extending the effective period of a prohibition of all commercial cannabis activities within the Coastal Zone of the unincorporated area of the County of Humboldt. The prohibition applies to cultivation, processing, manufacturing, testing, distribution or sales which might otherwise be conducted pursuant to state law. The ordinance extends provisions established under Ordinance No. 2583, which added section 31354 of Title III, Division 1, Chapter 3, Section B, Part 1 of Humboldt County Code (Coastal Zoning Regulations). The ordinances are intended to serve on an interim basis until such time as pending Humboldt County ordinances regulating Commercial Cannabis Activities in the Coastal Zone are fully enacted, following certification by the California Coastal Commission. The ordinance will remain in effect for up to 22 months and 15 days, unless repealed, or superseded by separate ordinance.
